#### III. News from the Field:

LTJG Steven Spaulding organized and carried out a fitness initiative emphasizing officer's fitness level in accordance with CCRF standards. Nine PHS officers and three civilian employees participated.

CDR Coleman submitted a proposal for a Work Adjustment, Peer Mentoring Program at the DC CMHS. The proposal was received with overwhelming support from management and is currently being piloted within the in-patient units. This program trains consumers to lead diversional activities and act as role models for their peers. The following officers are a part of this initiative: LT Michelle Peterman, LTJG Teshara Bouie, LT Terri Ellsworth, and LCDR Maria Bacilio.

CDR Coleman supports the public/private initiative of the DC CMHS by collectively working with "Our Turn Advocacy Program", (a consumer advocacy program of Washington, DC) to create a voice for the mentally challenged. Thus far, consumers under CDR Coleman's leadership have (1) Conducted a voter registration drive registering 48 first time voters. This group of consumers explained the voting process through a skit, used booth demonstrations and speakers, helped peers get to the polls and assisted with filling out forms/absentee ballots. (2) Consumers also conducted a consumer satisfaction survey which resulted in the largest turn-out in the past years. (3) Consumers also attended the Washington, DC Mayors Forum on The State of Mental Health Issues in the District. Consumers were awarded with certificates and gifts.

CDR Coleman has implemented an exercise program for seniors, focusing on the Surgeon General's theme of prevention. Most of these seniors range between the age of 62 to 85 years. They rarely exercised and lacked the mobility, tolerance, or endurance to perform 5 minutes of continuous simple range of motion exercise. To date, the seniors are performing 20-25 minutes of continuous exercises, three

times a week, using a 20 oz. bottle of water as a weight. Sitting, standing, and walking are a part of our routine. The program staff and seniors are thoroughly satisfied with our success.
