

#### In Center-Based Care the staff-to-child ratios are

1:3 or 2:7 for infants to 15 months; 1:4 or 2:9 for 15 months to 2.9 years; 1:10 for 2.9 to 7 years (State Licensing Regulations)

## In Family Child Care the staff-to-child ratios are

1:6 (with up to 3 children under 2 if at least 1 of these is 15 months and can walk unassisted) (State Licensing Regulations)

# In Group Family Child Care the staff-to-child ratios are

1:6 (with up to 3 children under 2 if at least 2 of these are 15 months and can walk unassisted) (State Licensing Regulations)
