832 children served by 14 grantees are in Early Head Start (2006 Early Head Start Funded Enrollment) (EHSNRC Database—September 2006)


60% of all the requests for child care to the child care resource and referral programs were for infant and toddler care (Child Care in America: 2006 State Fact Book, NACCRRA)



5,903 children under 3 receive early intervention services under IDEA, Part C



In Center-Based Care the staff-to-child ratios are

1:4 for birth to 2 years; 1:6 for 2 to 2.5 years; 1:8 for 2.5 to 3 years (State Licensing Regulations)

In Family Child Care the staff-to-child ratios are

1:8 (with 1 child under age 2); 1:8 (with 2 children under age 2 and 1 school-age child); 1:8 (with 3 children under age 2 and 3 schoolage children); 1:6 (with 4 children under age 2 and 2 school-age children)
