Children's Bureau Child and Family Services Reviews Status of Program Improvement Plans and Subsequent Child and Family Services Reviews

The Child Welfare Reviews Project collects information about the status of State Child and Family Services Review (CFSR) Program Improvement Plans (PIPs). The following chart includes information about the status of State PIPs and re-reviews.

As of July 9, 2008, all 50 States, the District of Columbia, and Puerto Rico have completed the Round One 2-year PIP implementation period, 14 States were reviewed in 2007, 18 States are being reviewed in 2008, and 11 States have been scheduled for review in 2009. The Children's Bureau has completed its evaluation of at least 40 of the Round One PIPs and determined that 34 States achieved all of their PIP goals and implemented all required PIP activities, thus rescinding any applicable penalties. Evaluations of the remaining completed PIPs are pending.
