Jurisdiction

The jurisdiction of the San Juan Quarantine Station includes all ports in Puerto Rico and the U. S. Virgin Islands (St. Thomas, St. Croix, and St. John).

Activities

- Respond to reports of illness or death on airplanes and maritime vessels (cruise and cargo) at international ports of entry within jurisdiction.
- Review medical records of immigrants who will reside permanently in the United States and notify state and local health departments of specific medical conditions.
- Monitor importations of animals, human products, and vectors that may pose a threat to human health.
- Partner with federal agencies, state and local health departments, medical providers, hospitals, and organizations in preparedness activities related to quarantine and isolation at ports of entry.
- Raise awareness among the port community of communicable diseases, and train staff on public health issues that impact a globally mobile population.
- Participate in teams and workgroups for CDC's Division of Global Migration and Quarantine, Quarantine and Border Health Services Branch.
