
#### The FNS Management Evaluation ("ME") Process

#### **FNS Management Evaluation**

#### The purpose is <u>not</u> to:



- make life a living "hell"...
- o "nit-pick"...
- get folks into trouble with their superiors

#### **MEs are a Management Tool...**

- Offers a chance to step back and assess how well things are going
- Provides technical assistan
- Allows sharing of "best practices"

#### **FNS Management Evaluation**

 Provides a reality check– compliance with federal regulations, policies and instructions



 Helps identify trends so regions can target technical assistance

#### Frequency of FNS ME's of State Agencies

#### FNS Regional Offices review States <u>as needed</u> for:

- Commodity component of the Child Nutrition Programs
- All other commodity programs (TEFAP, CSFP, FDPIR)

#### Regional Offices Have Flexibility In How They Approach and Perform Management Evaluations of Each State



#### **FNS Regional Office Flexibility**

#### Regions choose States

 State selection does not have to be rotational



Region may choose to visit local agencies

#### **FNS Regional Office Flexibility**

 Design of each ME based on Regional knowledge of State structure and operations...



 Regional staffing/travel funding is also a consideration



#### **FNS Regional Office Flexibility**

#### The ME may cross several programs in a State:

- Schools
- TEFAP
- CSFP
- FDPIR




