## **INTRODUCTION TO VOLUME II, MILITARY COMPENSATION BACKGROUND PAPERS**

Beginning with the 6<sup>th</sup> edition of *Military Compensation Background Papers*, tables showing the cost of individual compensation categories and the number of personnel receiving that compensation are separate from the text that describes the legislative history of the compensation. In previous editions, cost and personnel statistics were included with the text in a single volume. The tables on cost and personnel in this new Volume II include all the data of tables in the previous editions, updated through 2004 when statistical information has been available.

For the reader's convenience, chapters of Volume I include references to related cost tables in Volume II. Those references are found at or near the end of the relevant chapters. In the table nomenclature of Volume II, the first (Roman) number indicates the section of Volume I (II through V) in which the compensation category is discussed; the second (Arabic) number does not correspond to chapter numbering in Volume I. That number indicates only the order in which the categories are covered within a section.

For example, Table III-7 covers a compensation category found in section III of Volume I; the number 7 indicates only that the category is the seventh in order among the section III chapters for which cost and personnel statistics are provided. However, because table titles are identical to the chapter titles of Volume I, tables can be found in Volume II under the category names listed in the Table of Contents below. In cases where multiple types of cost are incurred by a compensation category discussed in a chapter of volume I, a table designator may include more than one table.
