To qualify for official weights, the warehouse must be able to receive and load out the grain shipped by rail over scales that are certified by AAR, the servicing rail, FGIS, or qualified independent third party. (*Official weights are a requirement of a Terminal Warehouse.*)

To provide official origin grades for rail or barge load out, the warehouse must either have a mechanical sampler agreement (*certified by FGIS*) or a "Route" sampler agreement (*i.e., cars are probed by a licensed sampler or inspector, and samples graded by recognized FGIS inspection agency*) with CCC.
