1 Overview

A Background

The U.S. Troops Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Appropriations Act, 2007 (Pub. L. 110-28) authorizes the Secretary to use FSA funds to administer CDP.

The 2005-2007 CDP payment software has been modified to include payments for quality. 5-DAP (Rev. 2), Amendment 13 provides procedure for using the CDP Estimated Calculated Payment Report (ECPR) and for issuing CDP payments now that quality is included.

A problem was also identified in the CDP quality application process that may result in an incorrect expected production calculation. 2005-2007 CDP Quality Application software has been modified to correct this problem.

B Purpose

This notice advises that:

- CDP Quality **payment and ECPR** software will:
 - be transmitted to County Offices on or about December 23, 2008
 - also be included in County Release No. 657/658, which will arrive in County Offices on or about January 16, 2009
- corrected CDP Quality **application** software will:
 - be transmitted to County Offices on or about December 23, 2008
 - also be included in County Release No. 657/658, which will arrive in County Offices on or about January 16, 2009
- steps will need to be taken to ensure that CDP Quality applications are correct after the software modification. Follow steps in paragraph 2 to correct applications.

2 Correcting CDP Quality Applications

A Overview

2005-2007 CDP Quality Application software required a correction because of a problem identified in the expected production calculation. Because of this problem, quality loss level production may be incorrect. County Offices must take steps to ensure that quality loss level production is calculated correctly before issuing any quality payments.

B County Office Action

County Offices shall follow steps in this table to ensure that quality loss level production has been calculated correctly.

Step	Action	
1	After following the instructions in Information Bulletin No. 4652, run an “ALL” batch of detailed ECPR’s according to 5-DAP (Rev. 2), paragraph 541.	
2	Review all detailed ECPR’s to identify all producers in the county that have applied for CDP Quality.	
3	For each producer determined in step 2 to have applied for CDP Quality, access each of the quality applications according to 5-DAP (Rev. 2), paragraph 428.	
4	After accessing the CDP Quality application, enter through to the Load QL Non-Contract Data Screen MHADLN01. See 5-DAP (Rev. 2), paragraph 431 for additional information.	
	IF the noncontract unaffected production field...	THEN...
	is blank	enter “1” in the non-contract unaffected production field and PRESS “Cmd5” to update.
	contains production	modify the existing non-contract unaffected production amount by increasing the number by “1” and PRESS “Cmd5” to update.
5	Before continuing, change the non-contract unaffected production back to the original amount and PRESS “Cmd5” to update.	
6	Enter through the remainder of the CDP Quality application process.	
7	Follow procedure in 5-DAP (Rev. 2), paragraph 441 to re-enter the original CDP quality approval date.	
8	Follow 5-DAP (Rev. 2), paragraph 541 to print new detailed ECPR’s, by specific producer, for each producer with an updated CDP Quality application.
