1 Overview

A Background

County Offices have been unable to view the details of CCC-962's for sold CCC-955/CCC-956's. Therefore, the TTPP system has been enhanced to allow national, State, and county users the ability to view CCC-962's for sold CCC-955/CCC-956's.

This enhancement is scheduled for immediate release.

B Purpose

This notice provides instructions to display CCC-962's for sold CCC-955/CCC-956's within the TTPP system.

- contact the State Office if further assistance is needed.

3 Enhanced TTPP System Functionality

A Accessing CCC-962's

County users will be able to view CCC-962's for CCC-955/CCC-956's that have been sold to a successor-in-interest. To access CCC-962's, users shall take the following steps.

Step	Action
1	From the left navigation on any TTPP screen, CLICK either of the following:
	"Quota Holder Data" "Bus descen Data"
	• Producer Data .
2	To search for a sold CCC-955/CCC-956, enter the applicable CCC-955/CCC-956
	number and CLICK "Submit".
3	CLICK "View CCC-962".

Note: "View CCC962" will only be displayed for CCC-955/CCC-956's in sold status.
