PETITION TO PARTICIPATE

SoundExchange, Inc. ("SoundExchange"), a nonprofit organization incorporated in the State of Delaware and jointly controlled by representatives of sound recording copyright owners and performers through an 18-member board of directors, on behalf of itself and the copyright owners on whose behalf it collects and distributes statutory royalties from business establishment services ("BES's"), submits this Petition to Participate in the above-referenced proceeding. This Petition is filed in response to the Copyright Royalty Board's Notice announcing the commencement of a proceeding "to determine the reasonable rates and terms for the making of an ephemeral recording of a sound recording for a later transmission by entities that transmit performances of a sound recording to business establishments." See 72 Fed. Reg. 584 (Jan. 5, 2007). That Notice instructed parties wishing to participate in such proceeding to file a Petition to Participate by February 5, 2007. See id.

The Librarian of Congress has previously designated SoundExchange as the sole entity to receive royalty fees and statements of account submitted by services purporting to operate as BES's under the provisions of the Section 112(e)(1) license that apply to

entities entitled to transmit under the limitation on exclusive rights specified by Section 114(d)(1)(C)(iv).¹ See 37 CFR § 262.4. In this capacity, SoundExchange represents not only the interests of those sound recording copyright owners who have specifically authorized SoundExchange to collect and distribute royalties on their behalf,² but also those unaffiliated sound recording copyright owners who are entitled to a portion of the royalties paid by BES's claiming the benefits of the statutory license.

The sound recording copyright owners who have specifically authorized SoundExchange to act as their agent for the collection and distribution of statutory royalties own or control the copyrights in 85% - 90% of all legitimate sound recordings legitimately sold annually in the United States. Accordingly, SoundExchange, on its own behalf and as an agent for sound recording copyright owners, has a significant interest in the royalty rates and terms that are the subject of this proceeding. Attached as Exhibit A is a list of SoundExchange's sound recording copyright owner members, each of whom has authorized and consented to SoundExchange's representation of them in this proceeding in accordance with 37 CFR § 351.1(b)(1)(ii)(E). This list may be amended as additional sound recording copyright owners authorize SoundExchange to represent their interests.

Therefore, while SoundExchange intends to engage in negotiations with various BES's and remains hopeful that it will reach a voluntary settlement, on behalf of those

members who have specifically authorized SoundExchange to act on their behalf, SoundExchange files this Petition to state that it will participate fully in the above-captioned proceeding to establish reasonable rates and terms for the BES's that operate under the Section 112(e)(1) statutory license and the Section 114(d)(1)(C)(iv) exemption.
