LAST WEEK

SENATE TRIAL CONTINUES -- HOUSE ON RECESS - Last week, the Senate resumed the trial of impeachment of the President. On Thursday, the Senate rejected a motion to dismiss the trial. As a result, the Senate will begin taking depositions from witnesses in the case. Both the Senate Majority Leader and Minority Leader have expressed interest in concluding the trial by February 12, 1999. Throughout the course of last week, the House was on recess.

HOUSE APPROPRIATIONS SUBCOMMITTEE MEMBERS - Members of the thirteen Appropriations subcommittees responsible for performing primary drafting of agency funding bills were recently named. Of notable interest to agriculture was the movement of Jose Serrano (D-NY) to become the ranking Democrat on the Commerce, Justice, and State Subcommittee. RELEASE OF PRESIDENT'S FY'2000 BUDGET - On Tuesday.

February 2, 1999, the President is scheduled to present the administration's FY2000 budget proposal to Congress. Details of the budget are not public, however, provisions of a Lands Legacy Initiative announced both on January 12th and mentioned in the State of Union Address will be included. The initiative seeks to preserve valuable lands for public enjoyment and open space preservation including increased funding for farmland protection.

LOOKING AHEAD

WATERSHED HEARING - A hearing has been scheduled by the House Transportation and Infrastructure Subcommittee on Water Resources (Chairman Sherwood Boehlert, R-NY) to discuss the Administration's FY2000 budget submission and programs under the Subcommittee's jurisdiction. Specifically, the Subcommittee has requested testimony regarding the NRCS small watershed program and also updates on the aging watershed infrastructure issue. Other likely witnesses at the hearing will include the Army Corps of Engineers, EPA, and the Tennessee Valley Authority.
