LAST WEEK:

FREEDOM TO E-FILE ACT – On Thursday May 19th, the Senate amended and passed by voice vote S. 777, the Freedom to E-File Act. The bill requires the Department of Agriculture to develop a system for customers to access Department forms and file paperwork online. The legislation is now cleared for the Presidents signature.

TMDL FILED HEARING – The Senate Environment and Public Works Committee (Chairman Smith, R-NH) held a field hearing on May 6, 2000 in Whitefield, New Hampshire. The purpose of the hearing was to receive testimony regarding the Environmental Protection Agencies' (EPA) proposed Total Maximum Daily Load (TMDL) rule and the National Pollution Discharge Elimination (NPDES) permit process. Over 150 persons attended the field hearing to hear testimony from three panels. Chuck Fox, EPA Assistant Administrator was the first to give testimony and to field questions and comments from the audience. Discussion topics ranged from TMDLs to proposed legislation from Senators Robert Smith (R-NH) and Michael Crapo (R-ID), the Water Pollution Program Enhancements Act of 2000, S. 2417.

Participants on other panels included the NH Timberland Owners Association, NH Cooperative Extension, NH Association of Conservation Districts, Champion International (Northeast Region), the Northeast Water Pollution Control Commission, and representatives of state forestry and environmental offices from Maine, New Hampshire and Vermont.

Major concerns were raised about the need for technical assistance so that agricultural and forestland users could continue to implement Best Management Plans (BMPs). State leaders also expressed concern about the cost of establishing TMDLs in order to meet EPA's requirements.

THIS WEEK:

AGRICULTURE APPROPRIATIONS – Both the House and the Senate Agriculture Appropriations Bills are ready for floor action. The House is expected to take action early this week. The Senate leadership has indicated that the Senate will not consider any appropriations legislation until it has passed the House. Funding levels in both Houses of the Congress are as follows:

TMDL HEARING – The Department Operations, Oversight, Nutrition, and Forestry Subcommittee (Chairman Goodlatte, R-VA) of the house Agriculture Committee will hold a field hearing on the impact of the proposed total maximum daily load regulations on agriculture. The regulations would set maximum daily limits on the amount of certain discharges into waterways.
