LAST WEEK -

HOUSE ADOPTS AGRICULTURE CONFERENCE REPORT - On Friday, the House adopted, 240-175, a House-Senate compromise agriculture spending measure for fiscal 2000 (HR 1906) that excludes contentious policy riders and includes a large amount of emergency aid to farmers. The \$8.7 million in emergency farm relief helped to ease tempers of lawmakers from both parties after a conference report was worked out behind closed doors by House and Senate GOP leaders.

The bill would provide \$69 billion for farm and food programs, of which \$14 billion is discretionary spending for fiscal 2000. Excluding the emergency funds, the bill is about 3 percent less than the administration requested but 11 percent more than fiscal 1999. Policy riders were left out of the measure that would have lifted sanctions against sending food and medicine to Cuba, and that would have extended the Northeast Dairy Compact, which favors small northeastern dairy farmers. Both issues faced possible veto by the Clinton administration.

HOUSE AND SENATE CLEARS CONTINUING SOLUTION - On Tuesday, the House passed a continuing resolution, 421-2, to keep the government in operation until October 21, three weeks beyond the start of the new fiscal year which began October 1. The Senate cleared the continuing resolution Tuesday night on a 98-1 vote, hours after the House passed the legislation. Once President Clinton signs the first of this fall's continuing resolutions, Congress and the chief executive will have until October 21 to complete the 13 fiscal 2000 spending bills. Senate Appropriations Chairman Ted Stevens, R-AK, said Republicans will be able to send Clinton the remaining spending bills by October 21, but that a least one more continuing resolution will be needed to give the president time to sign or veto the measure and Congress time to react to any additional vetoes.
