<u> Director Gil Coronado Testifies</u> <u>on Capitol Hill</u>

Selective Service System Director Gil Coronado testified in March before the House VA, HUD, and Independent Agencies Appropriations Subcommittee to defend the Agency's Fiscal Year 2001 budget request. The President's Budget proposes funding the Agency at \$24,480,000 in FY 2001.

Traditionally a very important annual appearance by the Director, this year's testimony seemed to generate an unusual amount of attention, evident by the attendance of many members of the subcommittee (8 out of the 13 members were in attendance).

The Director, accompanied by Deputy Director Willie L. Blanding, Jr., and Lewis C. Brodsky, Director of Public and Congressional Affairs, made a brief statement before facing questions from subcommittee members. The Director reported that compliance rates have continued to decline. The national compliance rate for men 18 to 25 years old is 88 percent for 1999. The compliance rate for draft-eligible men age 20 to 25 is 93 percent. This represents a 1 percent drop in each category from 1998. The Director explained that the low compliance rates are due to a lack of awareness across our Nation regarding the registration requirement.


The Director discussed several registration initiatives implemented in FY 1999 to counter the declining registration rates, such as telephonic registration, expanded operating hours for on-line registration, and "Early Submission," which permits 17-year-old men to submit registration information.

In response to a question from Rep. James T. Walsh (R-N.Y.), the Subcommittee Chairman, concerning other initiatives implemented by the Agency, the Director enthusiastically explained the new agreement between the Agency and the Immigration and Naturalization Service (INS). The agreement calls for the INS to revise their "Application to Adjust Permanent Resident Status" (Form I-485) to include a statement informing male immigrants that if they are between the ages of 18 and 25 years, their information will be shared with the Selective Service System for the purpose of registering them. "This has the potential over time to result in significant improvements in compliance rates," said the Director, "as we believe that immigrant men and high school dropouts form the largest segments of the male population failing to register."

Professional Development Course Training

Last March, at the Selective Service System's three Regions, more than 69 State Directors (SDs) and Reserve Force Officers (RFOs) participated in a training program that included a new Professional Development Course (PDC).

The Agency's Office of Operations Training Division developed this course, streamlined from 32 to 12 hours, to be included in the second phase of a two-phase training program for newly appointed SDs and RFOs.

All SDs and RFOs are required to complete a twophase initial training program within the first year

of their appointment to the Selective Service System. The first phase of the training program requires a review of materials about the Agency. The second phase requires the SDs and RFOs to participate in one and a half days of training to be conducted at their respective Region. During the PDC, participants are trained in the operations of their State Headquarters, Area Offices. Alternative Service Offices, and the Health Care Personnel Delivery System.

The Agency is pleased with the results of the first training sessions using the new PDC and plans another session at its Region I Headquarters in Illinois in July 2000. "Training for the State Directors and Reserve Force Officers

is continuous and comprehensive," says Col. Justo Gonzalez, Jr., Director of Operations, "but this initial training with the Professional Development Course, has proven successful in helping new State Directors and Reserve Force Officers quickly familiarize themselves with the Agency and their new responsibilities."

<u>Reserve Force Officer Honored</u> <u>for Community Service</u>

Lt. Col. Tony Libri, a Reserve Force Officer (RFO) assigned to the Selective Service System in Illinois, was recently honored for his years of community service to the town of Springfield.

Libri, who was featured in the 10th Anniversary edition of Springfield Magazine (pictured with his daughter Maria) has served the residents of Springfield for over 20 years, first as the WICS-TV Weekend Weatherman and currently as the Sangamon County Circuit Clerk.

It was in his position as County Circuit Clerk that Libri introduced and secured the passage of Thurmond-like legislation for Sangamon County, III. Passage of the legislation makes Selective Service registration a prerequisite for employment with the county. Libri was awarded the Selective Service Bronze Medal for his efforts.

An important part of Libri's life has always been his involvement in community service. As a member of over 10 community organizations, he averages almost 200 speeches a year.

Libri's desire to serve is not contained within the boundaries of Illinois. In 1997, Libri served in Bosnia and returned as one of Illinois' most decorated soldiers.



The heartbreaking hardship witnessed by Libri while in Bosnia, served to increase his dedication to the community and his belief in the importance of being a good citizen. He has passed these beliefs on to his daughter Maria, host of WRSP-TV's Fox Kids Club. She credits her father for inspiring her to never give up the quest to attain her dreams. This obviously has been good advice as both Libri and his daughter have become prominent personalities in their community.

Keeping it in the Family: Brothers Become Local Board Members






Director Coronado Travels to El Paso, Texas



Region III Gets New Detachment

According to the Director, declining registration rates are also due to declining resources. "The Agency has 40 percent less full-time employees than in previous years, and given the current fiscal structure, it is very difficult to achieve the goals that we're striving for," he said. "But we work very hard, and I am very proud of the work our people have done."

The Director emphasized that the FY 2001 appropriation request of \$24,480,000 "will be invested very prudently in one of the Nation's greatest security assets." "Your support of the President's Budget request," he continues, "will ensure that America maintains the Agency as a low-cost insurance policy against underestimating the nature and size of future threats our Armed Forces may face."

The Subcommittee is scheduled to announce its budget recommendations in late May, with the bill moving toward a vote in the House of Representatives in June or July.

Anton chose to register telephonically, while his mother looked on. "Technology is amazing," Anton said. "This was a very simple process."

Selective Service System reminder cards with a special Personal Identification Number (PIN) are sent to young men about to turn 18 years old. Upon receipt of the card the young man calls the toll free number provided. Once connected, he will be instructed to enter his Social Security number, date of birth, and the PIN he was provided. If his registration is successful, he will receive his Selective Service registration number over the phone and his acknowledgment card will be sent to him within two weeks.
