Frequently Asked Questions WMD Standardized Awareness Authorized Trainer (SAAT) Program

Question 1

Does the WMD Standardized Awareness Authorized Trainer (SAAT) Program AWR 160 series (AWR-160: Direct Delivery and AWR 160-1: Train the Trainer) replace the Emergency Response to Terrorism: Basic Concept (ERTBC) AWR-100, Train the Trainer AWR-101, and Self-Paced Course AWR-102?

Answer 1

Yes, the AWR 160 series replaces ERTBC AWR-100, Train the Trainer AWR-101, and Self-Paced AWR-102 courses. The curriculum in the AWR 160 series incorporates all the learning objectives of the ERTBC course at the awareness level except for the incident command element. However, incident command is addressed in greater detail in other ODP courses, including Incident Management/Unified Command for WMD/Terrorism Incidents (MGT 313) and Incident Command Training (MGT 360). Additionally, ODP coordinates with the NIMS Integration Center to ensure that all ODP courses with respect to incident command are NIMS compliant.

Question 2

What if the state or urban area has already negotiated for the development and/or delivery of other WMD awareness courses? Will states and urban areas now be required to participate instead in the National WMD Standardized Awareness Authorized Trainer Program?

Answer 2

All states and urban areas are strongly encouraged to participate in the National WMD Standardized Awareness Authorized Trainer Program in order to support the Homeland Security Presidential Directive (HSPD) 8 requirement to establish and maintain a comprehensive training program to meet the national preparedness goal. However, if a state or urban area has negotiated for the development and/or delivery of an alternative awareness course, they may proceed with that option. If a decision is made to proceed with the alternative WMD awareness course, the state or urban area will not be permitted to use ODP funds to support delivery unless the course is submitted through the established course approval process.

Question 3

Are states and urban areas allowed to have more than 3 persons per discipline participate in the training?

Answer 3

Yes, three persons per discipline is the minimum requirement, however states and urban areas

can have more than three per discipline certified as trainers. They should be aware however, that the anticipated maximum course size is 50 people.

Question 4

Can states and urban areas schedule multiple deliveries of the train-the-trainer course?

Answer 4

Yes, states and urban areas can schedule multiple deliveries as long as they coordinate them with their ODP State or Urban Area point of contact and the National Domestic Preparedness Consortium trainer for that state or urban area's region. The multiple deliveries should be scheduled to happen concurrently within the same week.

Question 5

Are other disciplines which are not clearly identified in HSPD-8 or mentioned in previous guidance authorized to participate in the National WMD Standardized Awareness Authorized Trainer (SAAT) Program? For example, if states and urban areas have previously extended awareness training to agriculture personnel, are they eligible to participate in this program?

Answer 5

Yes, states and urban areas are encouraged to be inclusive in their delivery of this course, particularly with regard to additional emergency response disciplines that have a need for WMD awareness.

Question 6

Will there be long-term requirements for authorized trainers to deliver the course a certain number of times?

Answer 6

Yes, however State Administrative Agency or UAWG POCs shall identify delivery requirements for authorized trainers in keeping with the State or Urban Area Strategy. For example, if an urban area has identified 6000 individuals requiring awareness training, the Urban Area Working Group might require each of its 30 authorized trainers to deliver training to 200 individuals in a specified time period.

Question 7

Can states and urban areas rely upon contractor support to meet the required minimum number of authorized trainers?

Answer 7

Yes, if states and urban areas deem appropriate, they can rely upon contractor support to meet their minimum number of authorized trainers (three per discipline). In doing so, they should bear in mind the long-term goal of the National WMD Standardized Awareness Authorized

Trainer (SAAT) Program, which is to institutionalize awareness training and build a core cadre of instructors who will carry out this training on an ongoing basis within their state and local area.
