[Implementation of Revised Standard Form 86 – Questionnaire for National Security Positions](#)

Beginning September 23, 2008, individuals required to undergo a background investigation for access to classified information will use a revised Standard Form 86 (SF 86). This updated form is used by the U.S. Government in conducting "background investigations and reinvestigations to establish that military personnel, applicants for or incumbents in national security positions, either employed by the Government or working for Government contractors, licensees, certificate holders, grantees, are eligible for a required security clearance." This standard form will be completed only after a conditional offer of employment has been made for a position requiring security clearance.

The Electronic Questionnaires for Investigations Processing (e-QIP) has been updated to include the newly revised form. In cases in which e-QIP is not available or accessible, the new SF 86 will be available as a "fillable" PDF file on OPM's website at: <http://www.opm.gov/forms/html/sf.asp>.

Upon implementation, all previous versions of the SF 86 will be destroyed. Agencies using the e-QIP system will automatically be converted to the new version. For e-QIP and paper requests in process at the time of implementation, there will be a limited transition period when both versions will be accepted. **OPM will not accept the previous versions of the SF 86 or e-QIP form after January 1, 2009.**

[New Rate Schedule for OPM Background Investigations Effective October 1, 2008](#)

The Office of Personnel Management's Federal Investigative Services Division (OPM-FISD), which offers standard background investigations as well as numerous special investigative products, announced that prices for these services will be going up effective October 1, 2008. Below is a table listing the more common investigation types and their new costs.

As reported in the September 10, 2008 *DPSAC News*, NIH will begin using a more stringent minimum background investigation for Public Trust Level 5 (PTL-5) positions, effective October 6. As of that date, the "Minimum Background Investigation (MBI)" will replace the National Agency Check with Inquiries and Credit Check (NACIC) as the new minimum investigation requirement for PTL-5 positions at NIH. This change will apply to approximately 20% of all NIH positions. For FY09 the "normal" MBI will cost \$591. - **Legal Names Required in NED**

Per the requirements of HSPD-12, DPSAC must use the individual's legal name on the ID Badge. Therefore, legal names must be entered into NED. Middle initials instead of the full middle names are permissible. Nicknames or abbreviated first names are not allowed (e.g., Dan for Daniel; JP Smith for John P. Smith; etc.). Individuals whose names have not been entered properly into NED will not be processed for an ID Badge.

FAQs

Q. Why are you going to investigate me? I'm only applying for an entry level job and I don't need a security clearance.

A. The interests of the national security require that all persons privileged to be employed in the departments and agencies of the Federal government shall be reliable, trustworthy, of good conduct and character, and of complete and unswerving loyalty to the United States. This means that the appointment of each civilian employee in any department or agency of the government is subject to investigation. The scope of the investigation will vary, depending on the nature of the position and the degree of harm that an individual in that position could cause.

The requirement to be investigated applies whether or not the position requires a security clearance to have access to classified national security information.

Q. Do I have to answer all the questions on the form? A lot of that information is already on my resume.

A. Yes. The resume is part of the application process. The Security Questionnaire is part of the investigation process. All of the questions should be answered fully, accurately and honestly.

Q. What will happen if I refuse to give you some of this personal information?

A. The investigation is a condition of employment. Providing the information is voluntary, but if you choose not to provide the required information, you will not meet the requirements of the job and will therefore not be considered further. If you are already employed by the Federal government, your appointment will be terminated. The courts have upheld this principle.
