# FY2008 Appropriations: Public Access Mandatory

Among other features, the bill makes **public** access to NIH-funded research information mandatory and requires all NIH-funded investigators to submit electronic manuscripts of their scientific work to the National Library of Medicine (NLM).

#### Discussion of CTSAs

- It is too early to measure the effects of the CTSAs in the clinical research arena; however, an ACD member predicted that the CTSAs will lead to the spread of best practices.
- The CTSA program has a committee investigating ways to support diverse and community-based young researchers within the program.
- The CTSA program will emphasize the bedside-tocommunity aspects of the research.

#### NIH Reform Act: Reauthorization

- The NIH Reform Act of 2006 reauthorizes NIH for 2007 and 2008.
- It calls for new processes for facilitating trans-NIH research.
- It establishes a Division of Program Coordination, Planning, and Strategic Initiatives (DPCPSI), which oversees OPASI.
- It creates a Council of Councils.
- It establishes a Common Fund to support trans-NIH
   research and calls for a large, biennial report on the state
   of biomedical and behavioral research, including the
   priorities and plans of the ICs.
- Other terms include a public process for reorganizing NIH programs.

#### Example of Recent Trans-NIH Initiative

- National Children's Study involves all NIH Institutes.
- Study receives Office of the Director funding.
- Nine vanguard sites have been launched, and there will be 105 sites eventually.
- Study will observe children from preconception to age 21.
- Recruitment will begin in 2008.

### Roadmap for Medical Research Program Update—New Initiatives

- Epigenetics (5-year program)
- Human Microbiome (5-year program)
- Protein-capture and phenotyping services and tools (staged approach)
- Connectivity map to discover linkages between diseases, drugs, and genetic manipulation (pilot study)

### NIH Working Group on Women in Biomedical Careers Update

- NIH cosponsored a study by the National Academies
   Committee on Women in Academic Science and Engineering.
- Report pointed to need to **help women see a career path** that allows them to reach their full intellectual potential.
- It concluded that unintentional biases and institutional structures hinder access and advancement of women in the sciences.

### NIH Working Group on Women in Biomedical Careers Update (continued)

- Consider recommendations from the National Academies report.
- Give attention to the NIH intramural community concerns.
- Consider broader context of girls and women in science.
- Provide special attention to issues of:
  - Barriers
  - Minority women scientists
  - Mentoring

# Center for Scientific Review (CSR) Improvements

# CSR has initiated changes to improve the peer review system, including but not limited to:

- Increasing communication and transparency
- Increasing efficiency and effectiveness
- Increasing consistency
- Increasing the recruitment of administrators

#### CSR Improvements (continued)

#### **CSR** intends to:

- Improve the alignment of Study Sections
- Shorten the review cycle
- Recruit and retain high-quality reviewers and lessen their burden
- Better identify significant, innovative, highimpact research

Future changes under consideration include: a) continuous receipt of applications, b) use of reviewer rewards, and c) editorial board reviews.

# Electronic Research Administration (eRA)

In the past year, NIH has taken large steps toward the fully **electronic submission** of research grant applications.

- About 80% of applications are now submitted electronically.
- Systems are performing well. A few complex programs are still in transition.

### Office of Extramural Research Improved Web-Based "Facts and Figures"

- Series of downloadable slides
- NIH extramural funding trends, numbers of grant applications, awards and success rates, mechanisms, types of programs, etc.
- Launching January 2008
- Features of the improved OER reporting Web site: enhancements to current items; one-stop shopping for reports; easier navigation; tools to customize reports; indications of most frequently visited reports; and links to other sources of information

### COPR Liaison Report to ACD

- Suggested increased synergy and exchange between the COPR and ACD. For example, a member of one group might join a work group from the other group.
- Encouraged retiring liaison and new (replacement) liaison to attend a meeting of the other group together.
- John C. Nelson, who attended the April COPR meeting, was very impressed by the scope and depth of the presentations, intensity of the discussions, and use of a meeting chair and procedures, such as voting (suggested for ACD).
- Dr. Zerhouni proposed that the COPR and ACD hold a common meeting some time in the future.
