FACT SHEET ON HIPDB INVESTIGATIVE SEARCHES

Background of the Healthcare Integrity and Protection Data Bank

The Healthcare Integrity and Protection Data Bank (HIPDB) was established to combat fraud and abuse in health insurance and health care delivery. Registered entities query the HIPDB using the Integrated Querying and Reporting Service (IQRS). The HIPDB can provide detailed information on prior criminal or fraudulent behavior that can be used to:

- Prepare for a trial or hearing.
- Improve investigative work.
- Assist with case selection.
- Assist in sentencing recommendations.

Investigative Search Capability

A key feature of the IQRS is an investigative search capability of HIPDB information. The investigative search capability permits browser-style searches that typically contain less identifying information than the standard structured queries available to non-law enforcement entities.

To execute an investigative search, access the IQRS by clicking Go to the IQRS on the NPDB-HIPDB home page. On the *Login* screen, enter your Data Bank Identification Number (DBID), User ID, and User Password into the corresponding fields and click Login. The Entity Registration Confirmation screen displays the most current data that the Data Banks have on file for your entity. On the Options screen, select Investigative Search. Federal law enforcement entities with HIPDB rights only will proceed immediately to the Search Purpose screen (Figure 1). All other authorized entities will proceed from the Options screen to the Select A Payment Method screen after choosing **Investigative Search**. If your entity does not have an Electronic Funds Transfer (EFT) account on file with the HIPDB, select the credit card option and provide a credit card number and expiration date. By law, Federal entities are not charged for HIPDB queries.

The Search Purpose screen will display after you select a method of payment. Indicate the purpose of the search from the displayed options. Choose whether you wish to query on individual or organization subjects on the *Investigative* Search Type screen, then provide identifying information

to help narrow the search on the *Individual (Organization)* Investigative Search screen.

You have the option of performing either a full text search or a field search. In a full text search, provide words or phrases for which the IQRS will search in the text of all reports in the HIPDB. Reports that contain these search words will result in a match. Reports that contain words related to the search words, such as synonyms and antonyms, will also result in a match. For a field search, complete any or all of the labeled fields and a search is conducted based on this input. The fields that may be searched include:

- Last, First, and Middle Name.
- City, State, and Zip Code.
- Date of Birth.
- Social Security Number (SSN) (without dashes or
- Individual Taxpayer Identification Number (ITIN) (without dashes or spaces).
- Drug Enforcement Administration (DEA) Number.
- State License Number.
- Federal Employer Identification Number (FEIN).
- National Provider Identifier (NPI) Number.
- Unique Physician Identification Number (UPIN).

You may also perform a combined full text and field search. To perform a combined search, enter search words in both the Full Text Search box and one or more of the Field boxes to combine the capabilities described above. Several wildcard characters and special symbols may be used to assist the search. For specific details about these characters and symbols, select Help on the Investigative Search screen.

Once you have entered its search criteria, select **Search** at the bottom of the screen. Entities are charged based on the number of searches performed, not on the number of search results or reports viewed. Each time you click **Search**, a charge of \$10 is assessed. Federal agencies are exempt by law from this fee.

Search Results

The Search Results screen displays a list of the reports that matched the search words provided. The total number of reports that matched displays at the top of the screen, followed by a summary of the first 15 reports that matched. The summaries are ranked according to the match score, with the highest score at the top of the list. Because of the scoring algorithm, reports on the same subject may not follow one another on the list. In fact, all reports on the same practitioner may not even be contained in the list, depending on the search words and the data in the reports.

From left to right, the fields displayed are:

- The order of the report in the list.
- The match score.
- The report type.
- The subject name.
- The date of birth for individual subjects.
- Either field of licensure, occupation (*Judgment Or Conviction Report* (JOCR) only), or specialty (*Adverse Action Report* (AAR) only).

Each report in the list is given a score based on the number of search words that match words in the report, as well as words that are related to the search words. If all of your search words match, then the match score is 100. If only one of your search terms matches and the others are only similar, lower scores are assigned. Scoring is also affected by the order and proximity of the matched terms within the reports, as well as their frequency. For example, reports that contain the same search term several times may have the same score, but the one with the search terms clustered

more closely may receive a higher score.

If you wish to view a detailed report, click on the report summary in the list. The detailed summary shows a JOCR, or AAR. The **Go to Best Hit** link at the top of the page will scroll to the words in the report that most closely match one of the search words. Matched words display in bright red and similar words in lesser shades of red. Each report contains a **Back to Document List** link at the bottom, which will return you to the query results screen.

Troubleshooting

If you receive no results from your investigative search, check to see that only the fields you wish to search are completed. Also, make sure to use the **Clear** button when adjusting a query or creating a new query. If you experience a HIPDB Interactive Error, the most likely cause is a timed-out search session. If no activity is recorded on the system for a period of time, the connection is terminated for security purposes. In this case, you must return to the *Login* screen (click **End Session & Return to Login)** and re-enter your DBID, User ID, and User Password in the corresponding fields. An Interactive Error may also occur when the system is unavailable for routine maintenance or backups.
