Conflict of Interest Policy

ddiction Science & Clinical Practice requires contributors to declare any conflicts of interest that might be construed as potentially influencing their contributions. This policy stems from our obligation to serve our readers by providing effective oversight of the publication's entire contents. Disclosure of a conflict of interest does not necessarily imply that an article's information is questionable or its conclusions biased; rather, disclosure lets readers judge for themselves how much weight to give a contributor's financial relationships when evaluating his or her contribution. Contributors should err on the side of caution when making disclosures; if there are any doubts, contributors should make a disclosure and allow the editorial board and staff to determine its relevance. Omission of a pertinent financial interest could, if later revealed, deal a severe blow to the credibility of the contributor's work.

Like most journals, *Addiction Science & Clinical Practice* is not able to confirm the accuracy of our contributors' disclosure statements. We rely on our contributors' veracity; of course, *Addiction Science & Clinical Practice* authors can also expect scrutiny of their statements by readers.

Potential conflicts of interest include, but are not limited to, grant support, employment (recent, present, or anticipated), patents (including pending or applied for), copyrights, and certain institutional or clinical affiliations. Financial compensation arrangements such as consultancies, advisory board positions, stock shares, and travel funding can also be sources of conflict.
