2 reporter will be better informed, the coverage
3 will be more accurate and so on.

4 MS. BRUHN: So, do they usually
5 make it?

6 MS. REBELLO: Do they usually make
7 it?

8 MS. BRUHN: In other words, do you
9 keep track? Do they --

10 MS. REBELLO: Yes.

11 MS. BRUHN: Do you keep track of
12 your success so that within a timely fashion,
13 you know, reporters are often on deadlines.
14 Are they usually able to speak to who they
15 want to speak to within a reasonably short
16 period of time?

17 MS. REBELLO: I can say we
18 certainly try our best. We don't do 100
19 percent, you know, we're not 100 percent
20 effective at that. Just from the sheer volume
21 of calls that we get, and you -- if you couple
22 that with, when we're dealing with an

1 outbreak, unfortunately, we're not going to
2 get to all the media inquiries.

3 But we've just added a mechanism
4 last year for our website. So, if you're a
5 reporter who doesn't really know FDA, and you
6 have a device question, you can send an email
7 online, and it goes to the two press officers
8 that handle those inquiries.

9 We also have been really trying to
10 develop our media lists -- or better -- to
11 make them better and trying to reach out as
12 much as we can. But, there's certainly room
13 for improvement.

15 MR. SMITH: I've got sort of a two-
16 part question, I guesst the first is, for
17 Heidi, and maybe Nancy. Do you share the
18 perspective that John showed in, you know,
19 clearly there's a desire and we heard from

21 and better communication. And, you know, do
22 you share that there's some more modern tools

1 to use that John talked about to do that in a
2 better way?

3 And then secondarily I guess for
4 everybody, in light of some of the perspective
5 that Ellen shared yesterday, and the horrible
6 mathematical acumen of the general public, how
7 do you deal with these things of probability
8 and even my guess is, bar charts and pie
9 charts are going to be a struggle for a
10 significant part. So, yes, the verbal
11 communication is tough, but I don't know that
12 -- I guess we have to test it, but how do you
13 look at that?

14 And is there any plans and would
15 there be an action plan from FDA to actually
16 look at that? And is that in your -- or may
17 be part of the strategic plan part we talked
18 about. I don't know.

19 MS. REBELLO: I can -- okay. Well,
20 I certainly really enjoyed your presentation,
21 Dr. Paling. And we are looking at ways to be
22 -- to better communicate. Like when we have

1 announcements of agency initiatives, and where
2 we have time, we really tried to do a multi-
3 media package and you know, not often, but we
4 have done in the past where we have a senior
5 official whose -- you know, we have a studio
6 over -- that they can go to and tape a message
7 to, as a different form of communication.

8 We have the Commissioner, has
9 Andy's Take on the website now. And it's a
10 forum for him to once a week, speak about an
11 issue to consumers. He also tapes it. So you
12 can hear his voice.

13 And then your second question was
14 about the numbers. And that's why I was
15 talking about context. Without context, I
16 think numbers, at least you know, we have a
17 very hard time sometimes explaining the
18 context around the numbers. And we would
19 really -- that's an area I think, we would
20 really find useful, if you could provide us
21 help with, maybe coming up with analogies.

1 analogies of risk to explain complex
2 information? We have risk assessments that
3 come out, and during the melamine in pet food,
4 we issued a joint news release with USDA. And
5 on a risk assessment that concluded
6 essentially that there was very low risk to
7 human health from consuming meat from hogs and
8 chickens known to have been fed animal feed
9 supplemented with pet food scraps that
10 contained melamine, which
11 was -- and that was you know, during the
12 melamine and pet food.

13 And so, we tried to -- and actually
14 we don't have any credit from this. USDA came
15 up with a way to try to explain it. And so
16 what we said in our news release was,
17 translated to consumption levels, this means
18 that a person weighing 132 pounds would have
19 to eat more than 800 pounds per day of pork or
20 food containing melamine and its compounds to
21 approach a level of consumption that would
22 cause a health concern.

1 It's a little wordy, but it really,
2 you know, it helped to translate the risk.
3 And we need to do more of that.

4 CHAIRMAN FISCHHOFF: Let's see.
5 Betsy, Marielos, Mike and then Ellen.

6 MS. SLEATH: I just had a comment
7 related to John's talk. One of your -- it was
8 excellent, by the way. One of your comments
9 was that telling patients they should
10 communicate with their healthcare
11 professionals about risks and benefits. And
12 I'm not convinced that healthcare
13 professionals have the adequate tools to
14 discuss risks and benefits.

15 I work in a pharmacy school. I've
16 studied communication for years. And so, I
17 would argue that we also have to think about
18 how do we educate healthcare professionals to
19 talk about risk, and at the same time, for the
20 public to feel as though they need to be
21 empowered on, How do I understand risk.

22 Because I think it's very grey

1 area. So, I know that each of your agencies,
2 or divisions has a website and showed us what
3 they do. But one question I have is, do you
4 have a risk communication section of your
5 overall web page, you know, that may be advice
6 for providers, advice for consumers. Is there
7 anything like that? And if not, I would
8 suggest that's something that should be
9 considered.

10 MS. REBELLO: I don't think that
11 there's a formal one-stop-shopping on risk
12 communication. I think it probably is
13 throughout the website. But not a centralized
14 place. But I'll definitely take that back.
15 That's good feedback.

16 MS. SLEATH: Because actually, I
17 tried to use your website before I came here
18 to find information to use in my class to
19 teach first year pharmacy students about the
20 FDA. Because at one of these meetings,
21 someone told me there was a curriculum. And
22 even though your website's getting better,

1 when you search things, it's still very hard
2 to find stuff. So, I would give that feedback
3 as well.

4 It just -- it's almost -- it's
5 impossible. For me, it was impossible.

6 MS. REBELLO: I'm sorry to hear
7 that. We are trying to improve upon that.

8 MS. MCNEILL: Hi. Good morning. As
9 far as the website goes, oh, I'm in the wrong
10 place, aren't I. Excuse me. Lorrie McNeill.

11 My office is responsible for managing the
12 Center for Biologic's website. And so my
13 staff are actively participating in the
14 agency's efforts to move to a new content
15 management system.

16 And they've been doing extensive
17 usability studies with a wide variety of
18 stakeholders, not only FDA staff, but they've
19 gone out to consumers, healthcare
20 professionals, industry representatives and
21 folks from a variety of organizations that
22 have an interest in the information that we

2 So, I think once we do this
3 transfer, which I think is supposed to happen
4 by the end of December, you will see a vast
5 improvement in the agency's site as far as
6 being able to navigate and find the
7 information that you're looking for.

8 So, we're getting there. But you
9 know, it's a very painful process and it's
10 very time consuming. But I think it's
11 supposed to be done by the end of the year.

12 CHAIRMAN FISCHHOFF: Marielos.

13 MS. VEGA: I do also agree with
14 what just Betsy had to say. I work in a
15 medical institution. I went to nursing
16 school. And I have never seen any formal
17 training in risk communication, so I think
18 your point is very well taken.

19 This question, I think, is for
20 Heidi. In this meeting, and over the past
21 meetings we have discussed the importance of
22 perhaps having a single voice, or a

1 spokesperson for the FDA when communicating to
2 the public, especially emergency situations.
3 Is there a reason why this hasn't happened?
4 That there is one spokesperson for the FDA?

5 MS. REBELLO: I mean, I know that
6 I've heard that in the past meetings. And
7 it's you know, it's been brought to management
8 and considering. I will tell you that our
9 issues are so diverse, that it's oftentimes,
10 we go to the best technical expert to be able
11 to bring that person to talk to reporters, to
12 the public. But I understand your need and
13 suggestion, and we'll explore it.

14 CHAIRMAN FISCHHOFF: Mike.

15 MR. GOLDSTEIN: I too want to thank
16 everybody for their presentations today. And
17 I want to start with John's because I think
18 there's so many opportunities we have to make
19 something simple, and do it effectively. And
20 your recommendations, every single one of
21 them, I can endorse 100 percent, something FDA
22 could start to do tomorrow.

1 And the very first one, I think it
2 was the first one, letting people know that
3 all drugs have risks and benefits. Yes, the
4 effort is to make drugs and devices and foods
5 that's safe and effective as possible. And
6 that's what FDA is trying to do. But all of
7 these devices and drugs have risks and
8 benefits.

9 And then to explain it in ways that
10 folks can understand. So there's some very
11 basic concepts that are really, really, simple
12 and effective, I think, easily applied.

13 And then, AnnaMaria's presentation
14 just blew me away. The preparedness that was
15 demonstrated in how you work with industry,
16 really, to -- it's mostly industry, I guess,
17 to prepare.

18 And I think there are lessons
19 learned there. And I know they're resource
20 limitations, but you have talked about them
21 before. But to the degree that you can
22 approximate a process that is in place in the

1 commercial world, I think would be fantastic.

2 To think about the preparedness.

3 And part of the preparedness has to
4 do with others have mentioned, Betsy mentioned
5 just before. The need to help our clinicians
6 have these conversations with patients when an
7 event occurs. And they need help. Training,
8 yes. And I do training in this area. So I
9 know some training occurs, not enough. We
10 need to use, and I think, some core principles
11 like the ones that John mentioned, as the
12 starting place.

13 But then, we also need the tools.
14 And AnnaMaria talked about the effort that
15 they put into helping those affective
16 clinicians who already had some training, use
17 some specific tools and have some specific
18 language, so that they can help patients to
19 address both their fears, to make the right
20 decisions together, so that they can mitigate
21 any risks.

22 So, I think all those things are so

1 important and so valuable. And we can learn
2 some lessons from them. It does require some
3 shifting of resources, some more resources,
4 perhaps some more partnering with the
5 commercial side, so that those things can be
6 put in place.

7 But I don't think there's any --
8 what's the right word -- excuse comes to mind.

9 If the FDA really wants to -- and this is not
10 for the FDA. This is for above the FDA,
11 whoever makes the decisions. If we want to be
12 as safe and effective as possible, then we
13 need to be prepared. And then we need to
14 adopt the kinds of principles and strategies
15 and processes that industry is adopting in
16 order to do the best job that they can.

17 So, somebody needs to get that
18 message. We need to have the same kind of
19 processes in place. Because we're -- where
20 FDA is dealing with so many more important
21 risks, when we talk about the food supply,
22 when we talk about the millions of people who

1 are taking -- hundreds of millions of people
2 who are taking pharmaceutical agents that
3 can't be reached through industry as easily,
4 it really requires this kind of preparedness.

5 And I think we have to invest as a
6 country in the preparedness. So, I'll get off
7 my soap box.

8 CHAIRMAN FISCHHOFF: Thanks. Ellen
9 and then Linda.

10 MS. PETERS: I wanted to return to
11 a topic that Dr. Smith brought up, around
12 numbers are difficult. And the importance of
13 communicating numbers. One thing that
14 sometimes comes up in the risk communication
15 literature, and this is something that Baruch
16 has actually written about, is that sometimes
17 it seems that some communication is so
18 difficult that we shouldn't bother.

19 That it's just too difficult.
20 There's not a way to get around people who are
21 innumerate, who aren't as good with numbers.
22 And I wanted to actually point back to one of

1 the analogies that John showed. One of these
2 great visuals, but make a slightly different
3 point from it.

4 He brought up the point of the bees
5 being an incredibly efficient, very efficient
6 as a hive. But then when you slow it down,
7 and you look at all the mistakes, they're
8 making a lot of mistakes. They're bumping
9 into each other. But the point I'd like to
10 make is, that they keep on trying. They might
11 have gotten knocked down to the ground, but
12 they got back up again and they continued to
13 try to get into the hive.

14 And it worked eventually. Just
15 like the little engine that could, eventually
16 made it over the hill, if we keep trying to
17 figure out ways to communicate the numbers, we
18 will in the end, end up with better informed
19 patients, and hopefully with better health in
20 the end. And that's what we're looking for.

21 A couple of other points just along
22 that same line. We know a bit at this point

1 about how to communicate numeric information.

2 We don't know everything. I believe that we
3 need more testing with less numerate
4 populations who aren't as good with numbers.

5 In particular, I think we need more
6 testing with elderly adults, who as a
7 population, tend to be less numerate. But in
8 addition to that, because of declines of
9 cognitive processing, they're also less
10 flexible with change. They're less flexible
11 with new types of information. And I think we
12 need more testing specifically with them.

13 In addition, I think we need more
14 testing with them, because they are the ones
15 that consume the large proportion of our
16 pharmaceuticals. And so in particular, it's
17 important to understand how they would react
18 to this kind of thing. We actually don't know
19 much about that yet.

20 Some of the things that we do know,
21 though, in terms of how to communicate numbers
22 is, we need to use judgments. We need to use

1 judgment in what format to present a number
2 in. So, some things we know already, are that
3 if you use verbal labels. Some of the verbal
4 labels that John was talking about, in
5 communicating risks, that is going to lead to
6 probably the greatest risk perception of the
7 side effects based on the studies that have
8 been published so far.

9 You can use frequency
10 presentations. One out of 10,000, for
11 example. Or you could use percentage formats.

12 I can't even do that translation quickly, but
13 one percent versus one out of 100. We know
14 that highly numerate people, there's not going
15 to be much of a difference, regardless of what
16 format you present that number in, unless you
17 use the verbal labels, by the way.

18 But if you use actual numbers, it's not going
19 to make much of a difference to people who are
20 good with numbers.

21 For people who are less numerate,
22 if you use a frequency presentation, it

1 actually will connote greater risk
2 perceptions. It will effectively deliver more
3 risk is there if you use one out of 100, than
4 if you use one percent out of 100, for people
5 who are less good with numbers.

6 And so, it's not that one is better
7 than the other, it's that there's a choice to
8 be made. If it is deserving for a greater
9 risk to be communicated there, then the FDA,
10 or whoever the communicator is, needs to make
11 a choice. If it appears as if people are
12 fearful and anxious, and you want to quell
13 some of that, some undue fear at that point,
14 then using a percentage format may be the
15 better way to do that. But it's a choice.
16 It's a judgment call.

17 John brought up the idea of
18 framing. And whether you frame information in
19 a negative frame, the proportion of people who
20 will get the side effect, or a positive frame,
21 the number of people who will not get that
22 side effect. And he suggested using both

1 frames.

2 Again, there's an issue with
3 numeracy here. If you use a single frame,
4 people who are more numerate, it's not going
5 to make much of a difference. The frame isn't
6 going to effect them as much. It affects them
7 some, but not as much.

8 People who are less numerate are
9 much more affected by those frames of
10 information. I would claim, it's actually not
11 clear what's going to happen if you present
12 both frames of the information though. It
13 needs to be tested. It could be that what
14 will happen, is if you present both frames of
15 the information, you're going to help the less
16 numerate to better understand the complexity
17 really that's involved in a single number.
18 And they'll get more meaning from that.

19 On the other hand, there's other
20 data that suggests that the more information,
21 the more numbers you provide, and particular
22 to less numerate people, the less they

1 comprehend. And so, it's not entirely clear
2 what's going to happen. And as far as I know,
3 it hasn't been tested. So it's another case,
4 where there's an empirical investigation that
5 needs to be done. It's not quite that simple.

6 And what it comes down to again,
7 and I always hate bashing the FDA over the
8 head on this over and over, is we need
9 testing. We need testing to make sure that
10 what we're doing is going to deliver the best
11 health to our patients and our consumers. And
12 in the end, we need testing to be able to
13 ensure that the U.S. public is getting what
14 they deserve.

15 CHAIRMAN FISCHHOFF: Let's see.
16 Linda, Marielos and then Christine.

19 presentations. And I'm still trying to digest
20 what Ms. Rebello talked about. Because the

1 out and the questions that you have, you have
2 a whole list of questions. And I really can't
3 think of anything that is more important to
4 the charge of this committee than trying to
5 answer the questions.

6 We just heard from John Paling and
7 Ellen Peters, that even coming up with an
8 answer to something like putting out risks and
9 benefits and probabilities is something that
10 needs a lot of thought here. So, my question
11 to you is, have you ever had an internal,
12 strategic assessment of your office? Because
13 the list you have is so long.

14 I mean, you could pick any one of
15 these things like we need to do better at
16 evaluating, and each one of those would
17 require an assessment of what you're doing
18 now, your resources, your ideas, who else you
19 could call on in the agency. So, moving ahead
20 strategically to do better, would require
21 something like that.

22 And then, I would suggest a

1 strategic plan to figure out how each one of
2 these things that you would like to
3 accomplish, each of which is enormously
4 important for the public, is going to be
5 carried out and by whom.

6 MS. REBELLO: Thank you. For your
7 question about the internal strategic
8 assessment, I'm actually, I'm not sure if
9 we've done anything formally. I know that
10 when we -- after an event, or after an
11 announcement, or we roll out a major
12 initiative, we do take the time, not always,
13 but we do do it as much as we can, to go in
14 and to reassess where our strengths and
15 weaknesses were.

16 We did that with the Heparin.
17 Actually, the CDER lead that. And I think
18 throughout the agency, folks do that as well,
19 in terms of for communications.

20 But you know, like I mentioned, we
21 need to do a better job at that. I feel like
22 a broken record. But your insights are very

2 MS. NEUHAUSER: Well, just to
3 clarify a little bit, you can do sort of
4 piecemeal assessments of this issue and that
5 issue, but that kind of approach is probably
6 not going to get you where you want to go.
7 And it won't really respond to what Congress
8 is asking in terms of improving the risk
9 communication capabilities and activities of
10 the FDA, which relies so heavily on your
11 office.

12 And so, my question is really an
13 agency-wide question. Rather than necessarily
14 a question for your office.

15 MS. REBELLO: I see.

17 the committee to consider in the light of the
18 Congressional requirements under the new Act.

20 said, it reminded me in terms of the issue of
21 framing. It reminded me of a case in our

1 staff who is multi-cultural. So, there was
2 the case of this patient, hispanic patient,
3 monolingual, who had a test for colon cancer,
4 a blood test. And the test was positive

5 So, a letter was sent to the
6 patient, saying the test was positive and that
7 she needed to come in. The patient never came
8 in, and there was no followup. Eventually she
9 came in, but it was already about two and a
10 half years later. And to the patient's
11 understanding, the positive in her culture
12 meant something good.

13 So, she was under the impression
14 then everything was fine, she didn't have to
15 worry about it. Of course, the symptoms
16 persist. She continued bleeding, and
17 eventually she came in. But that is when the
18 framing that I need to state, it is more with
19 difference of groups, it's very important.
20 Because we have no -- we know how we
21 understand, positive and negative, but we have
22 no clue how different groups understand it.

1 So, it can mean life and death for
2 some people. So I'm glad you brought that up.

3 CHAIRMAN FISCHHOFF: Okay.
4 Christine, Mike, and then Musa.

5 MS. BRUHN: John, I want to thank
6 you especially for that last list at the end.

7 And I'm sorry we don't have it in our papers,
8 but I will look forward to seeing it on the
9 minutes as we get posted. But when you went
10 through it, I was thinking right on for each
11 one of them. So, thank you for putting that
12 together.

13 Now, I wanted to make a comment on
14 relative comparisons. Should you compare
15 risks from one topic to -- from one category
16 to another. I know it's often in the
17 literature they suggest don't do relative
18 comparisons. My colleagues and I tested this
19 in the area of pesticide risks with parents of
20 young children. And we compared the residues
21 that could be on fruits and vegetables with
22 driving a car under certain circumstances, or

1 eating a peanut butter sandwich on certain
2 circumstances.

3 We had six or seven relative
4 comparisons. And the results from this where
5 people appreciated having additional
6 information. Because it put the risk in
7 comparison. So if that showed them that the
8 risks for many residue in, on fruits and
9 vegetables was indeed very low, and even
10 though it was still there, it was low. They
11 didn't find all of the risks credible.

12 They didn't believe there was any
13 risk from eating peanut butter sandwich, other
14 than perhaps choking. And this again goes to
15 one of Ellen's points about people come from a
16 different context than you. I did this with a
17 toxicologist, and of course, we were thinking
18 of apple toxin and mold. But the public
19 didn't know about that.

20 So, but the main thing from the
21 comparison was, that was additional
22 information and the people wanted all the

1 information they could get. So that was
2 useful for them.

3 Now, one of your things that I
4 thought was very interesting, and you gave us
5 even slides on it, was the visualization of a
6 risk. Like the pie chart, and then in your
7 diagrams here, you have like two people with -
8 - two people lines with lots of other lines.
9 And I wanted to have a question for Ellen.

10 Has anyone tested visualization as
11 far as, does that give people a better concept
12 of relative risk? And does -- how does it
13 impact numerate and the less numerate
14 populations?

15 MS. PETERS: There's been some very
16 nice work done by Angie Fagerlin and Peter
17 Ubel, Brian Zikmund-Fisher, and a few other
18 people at the University of Michigan, looking
19 specifically at things like comprehension of
20 numbers from tables, versus comprehension from
21 what they would call a pictograph.

22 Where a pictograph is basically, if

1 you can picture sort of a 10 by 10 table of
2 squares. And you can then mark the number of
3 people at risk of a side effect, for example.

4 And what you can see is, you can see in that
5 pictograph, the number of people at risk, and
6 the number of people not at risk within a
7 single, fairly small space on a piece of
8 paper.

9 And what they find is, that people
10 tend to believe that tables are more effective
11 if you ask them. But they actually understand
12 more of the gist of the information if it's --
13 if the information is provided in one of these
14 kind of graphical formats, like a pictograph.

15 And it's fairly new research. I
16 don't remember if they looked at numeracy. My
17 expectation would be that it makes a bigger
18 difference for the less numerate people, and
19 that for the highly numerate, it doesn't make
20 as much of a difference, but maybe still,
21 makes some difference because it does provide
22 some of that context for them.

1 MS. BRUHN: That's very useful.
2 Thank you. And I'm wondering, do we know that
3 much? If we -- are we ending up perhaps
4 misleading the public if we show a pictogram
5 that's based on averages, if there's a
6 situation that people with certain
7 circumstances are more at risk? And you know,
8 we're always making decisions here when
9 there's not complete certainty.

10 MS. PETERS: Yes, a very good
11 question. So, I mean, you're bringing up sort
12 of two different issues here. One is, we give
13 a precise number, but there's almost always
14 uncertainty around that number. So, that's
15 one issue. It's a very big issue. There's
16 actually a working group at the National
17 Cancer Institute that's just starting up
18 looking at these ideas of ambiguity, and how
19 do you communicate ambiguity and how do people
20 understand ambiguity.

21 There's actually not a lot known
22 about that. There's a little bit. And you can

1 -- we can talk about it offline. There's just
2 a little bit known, and it's kind of in
3 sideline literatures. Unless Baruch knows
4 more about this. I'm hearing him down there
5 mumble a little bit. Did you want to kick in
6 there?

9 of your question was, we often present
10 information about the average person, or you
11 know across this Group of 100,000 that were
12 tested. But it may be that people who have a
13 particular physiological profile are more at
14 risk, or less at risk.

15 And you know, it gets at the idea
16 of using the best information that you have
17 available to help this particular patient make
18 the best informed choice. Sometimes what we
19 have is only that average. And I'm ignoring
20 the ambiguity at this moment. Sometimes what
21 we have is more targeted information, and you
22 know, I would claim, that if we can provide

1 that more targeted information, we should.

2 It's some times quite difficult to
3 come up with though. That's easier said than
4 done. In terms of a federal agency, they're
5 also often trying to provide information to
6 everybody. And they're trying to help people
7 as best they can. So if you're talking about
8 having the resources to send a single
9 communication out, that average is probably
10 what you should send out.

11 Maybe with a little additional
12 information if there really are some big
13 differences around physiological profiles or
14 gender or something like that.

15 MS. BRUHN: It's like Maria's
16 presentation. It worked well for lots of
17 people, but there were some specific groups
18 that it didn't work well with.

19 MS. PETERS: Right. Yes. Great
20 questions though.

1 MR. GOLDSTEIN: This is great. I
2 love the interaction and the discussion.
3 Because I learn something every round. And
4 it's been -- I raise my hand, and I have
5 something say, but it's very different now
6 after hearing people. What I've learned from
7 Ellen is that, all methods of risk
8 communication have risks and benefits. That
9 there's no one way that we're going to find
10 that's going to work for all people.

11 And actually, I learned this from
12 reading Howard Gardner, who's a cognitive
13 psychologist. We have a cognitive
14 psychologist in the audience who may know him.

15 And he's the person who came up with the
16 concept of multiple intelligence and there is
17 evidence that people are different in terms of
18 their way in which they learn and understand.

19 Some people are more visual, some
20 people are more verbal. Yes, in general, we
21 can study population and learn the best way.
22 But it's not going to work equally well for

1 all people because of their differences. On
2 the other hand, he also showed, that when you
3 show information in multiple formats,
4 comprehension increases and actually, that
5 gets translated into taking that information
6 and acting on it.

7 So, my view would be that we want
8 in the current level of understanding, we want
9 to provide as many different methods of
10 helping people to understand the meaning of
11 the information we're conveying as possible.
12 We want to continue to test to see what's the
13 best way. But it's never going to be the best
14 for every person, because there are
15 differences.

16 So, there's only so much that the
17 FDA can do. The FDA can gather information,
18 they can put it into formats that are
19 understandable and make those available for
20 patients and providers. But then, I do think
21 it's up to providers to fully take into
22 account, the specific needs of a given person,

1 given their culture and background, to help
2 them to understand so that they make the
3 choices.

4 That kind of a conversation,
5 communication, is only going to take place in
6 the context of a relationship. And the FDA is
7 never going to be able to recreate that. They
8 can only promote that. So, I would argue that
9 we need to, again, take what John's core
10 statements have helped me to realize, that
11 this is what the risk is, this is what the
12 benefit is. There's risks and benefits.

13 Different people have different
14 levels of risks and benefits, because there's
15 uncertainty about that. So, here's what we
16 know. Refer people to credible sources, so
17 they can have the conversations that are
18 likely to enhance understanding and decision-
19 making. And train people who are having those
20 conversations to do it effectively. That's my
21 simplest way of putting this all together so
22 far.

1 And I'm sure it will change as we
2 go around the room again.

6 what the last speaker was saying. But to get
7 back to Dr. Bruhn, when it comes to reporting
8 information in terms of numbers, it's a real
9 challenge, based on what we know and what we
10 don't know.

11 A very good example is an article
12 that appeared in the Wall Street Journal
13 today. I think it was posted on line last
14 night. It was an interview that one of the
15 subject matter experts in my center did, on
16 RotaTeq vaccine, which is a Rotavirus vaccine.

17 A similar vaccine was withdrawn from the
18 market, back in 1999 because of an increased
19 rate of a specific, serious adverse event,
20 following administration, vaccine
21 administration.

1 Journal had submitted a Freedom of Information
2 request for adverse event data and had gotten
3 all of these numbers and wanted some help
4 understanding what they meant. The interview
5 itself was highly technical, because Dr. Ball,
6 who heads our biostatistics office, had to get
7 into the weeds of explaining relative
8 reporting rates of the current vaccine, versus
9 the previous vaccine, and all of the caveats
10 of what we don't know.

11 We know how many doses are
12 distributed by the manufacturers. But what we
13 don't know, is how many are actually
14 administered. The numerator in the case, or
15 excuse me, the denominator, of the number of
16 doses distributed, is considered confidential
17 commercial information by the manufacturers.
18 So, while we know what that number is, we
19 can't tell the reporters or other
20 stakeholders.

21 So, it's really difficult to put
22 this type of information into context and

1 explain it why we say, we don't believe
2 there's an increased risk based on what we
3 see, what we've seen. Dr. Ball was able to
4 explain this very well to the reporter, but he
5 was a highly educated, you know, on this
6 particular issue, it was as Bob said to me
7 afterwards, the most technical interview he's
8 ever done.

9 We often don't have the luxury of
10 time to do that with reporters. In this case,
11 he worked on the story for a couple of weeks.

12 He spoke with us, he spoke with the Center
13 for Disease Control. He spoke with the
14 manufacturer. He spoke with the World Health
15 Organization. So, it was somebody who had
16 time to develop the story and really get the
17 story right.

18 And Heidi could comment on this
19 more than I could, but oftentimes, when we
20 hear about an interview request from Heidi's
21 office, it's with about this much turnaround
22 time. The reporter has a deadline. They want

1 very specific, detailed information. Our
2 subject matter experts may not be available to
3 provide that kind of context.

4 So, it's an added problem for us.
5 We want to get that information out there.

7 meaningful.

9 Musa and then Linda.

10 MS. MAYER: So, I'm sitting here
11 trying to absorb and sort of filter everything
12 that we've heard through what I know best,
13 which is, how breast cancer patients
14 understand the risks and benefits of the
15 treatments that they choose, and what the
16 sources of their understanding really are.

17 And as best I can determine, apart
18 from the information which is usually -- I say
19 usually - incomplete, that they get from
20 their healthcare providers, they are also
21 making decisions based on anecdotes, stories
22 that they hear from other patients, and media

1 coverage of treatments that are emerging. And
2 to some extent, from advertising. That's
3 probably more an issue for women with advanced
4 cancer.

5 But you see, breast cancer is
6 always in the news. I don't know -- I mean,
7 I'm aware of it because I follow it. But
8 there's a constant, sort of media attention,
9 on emerging breast cancer treatment, like
10 other major and common diseases. It's just
11 always there. It's also very feared. So that
12 creates a certain climate as well.

13 As a result of all of these factors
14 converging, and as a result of out not quite
15 being there in terms of what science
16 understands, we over-treat primary breast
17 cancer to a degree that's probably
18 unimaginable to most people. About three-
19 quarters of women diagnosed with breast cancer
20 do not need any additional treatment past
21 their surgery and possibly radiation to the
22 local area.

1 And yet, most of them are receiving
2 very toxic drugs -- chemotherapy and hormonal
3 treatments -- that have a both very short,
4 serious -- short and long term consequences.
5 In -- and how they make those decisions is
6 often based on their emotional state. It's
7 based on their perceptions of safety, which
8 may or may not be true, on their perceptions
9 of effectiveness, which are almost always
10 exaggerated, and on their perceptions of what
11 everybody else is doing. That is, this is the
12 standard of care.

13 If ever there is an areas where
14 there is a lack of truly informed consent, I
15 think this is a perfect example of that. And
16 there are a lot of reasons. It's too complex
17 an issue to really talk about in detail here.

18 But all of the factors that all of the
19 speakers have brought up, in a way, come to
20 bear. The lack of numeric communication, the
21 lack of visual aids that might help patients
22 understand what their risk of recurrence is,

1 and what their benefit for choosing these
2 treatments, the way in which treatment choices
3 are framed, the use of absolute versus
4 relative risks and benefits of the treatments
5 -- all of these factors come into play in the
6 most intricate way.

7 And so I'm sitting here thinking,
8 how could FDA have a positive influence in
9 these factors? And it just -- it seems to me
10 that to the extent that FDA can communicate
11 clearly in all these areas, and discuss -- I
12 suppose it's really in terms of individual
13 drugs I'm talking about here, and also
14 procedures, devices and so on, that are used.

15 As clearly as possible, that will offer so
16 much benefit not only to patients, but to
17 physicians as well, who are also at a loss.

18 We have one tool that is sort of
19 like a light -- it makes use of many of these
20 things. It's called Adjuvant! Online. And
21 it's a way for -- and it offers a visual aid
22 and clearly quantified information. A way for

1 an oncologist and a patient to sit down
2 together and look very clearly at information
3 -- which is abstracted from the latest
4 clinical trials data -- at what the actual
5 benefits are from selecting treatments.

6 However, there is no risk
7 information incorporated. It's all benefits.

8 That -- so it's only, in a way, half of the
9 picture. And I'm just thinking that FDA could
10 play a really significant role, in providing
11 the real tools that would enable the
12 scientists who are constructing tools like
13 this to take it the extra step.

14 And that there really isn't any
15 other honest broker, if you will, who is in a
16 position to do that. To actually help provide
17 the numbers in a way that's transparent, both
18 to patients and to physicians. I was so
19 heartened to hear Paul Seligman say that with
20 ten drugs, they are trying the drug facts box.

21 Because that's exactly the kind of tool we
22 need, desperately need, I think.

2 process for information gathering an decision
3 making. To ensure such transparency, at the

9 -- the open public-hearing speaker -- at the

5 Just to situate myself in Health
6 Canada, Health Canada is made up of a number
7 of branches, one of them being the health
8 products and foods branch. It has a scope of
9 responsibilities similar to what you heard
10 yesterday from the centers, in that it ranges
11 from foods, veterinary drug products,
12 pharmaceuticals, biologics, medical devices as
13 well as natural health products.

14 Within that branch, I work in the
15 marketed health products directorate, and the
16 scope of our responsibility is post-market
17 surveillance for pharmaceuticals, biologics,
18 natural health products and medical devices.

19 We've made risk communications a
20 natural priority area for a number of years.
21 Some of the things that we've been working on
22 are to make risk communications. Both our

1 products and our processes more consistent and
2 more transparent. A number of years back, we

9 content and the nature of distribution for
10 Dear Doctor letters, and notices to hospitals
11 that are issued by the industry. And as well,
12 we put forward the principle that there should
13 be a companion piece for that called a public
14 communication that in lay language is the same
15 messaging, but designed for the public.

16 Because those dear healthcare professional
17 documents were made available on our website,
18 and we felt that that companion document was
19 really necessary.

20 In addition, last month we issued a
21 guidance document which explains the -- it has
22 a very long name. But it's essentially the

1 current risk communication document. What
2 they are, and how we use them. So, for the 13
3 different types of risk communication

7 bring some transparency and also some
8 predictability to the process.

9 So, what are the documents, what
10 are some of the considerations for when we
11 would use one or the other, and what are the
12 typical ways in which we distribute those.
13 So, again, we were quite pleased to be able to
14 issue that and we feel that's an initial step
15 for us in laying out a baseline of what we do.

16 Because we're also very interested, like the
17 FDA, in looking at those processes and
18 products, and how do we challenge them.

19 One of our important outreach
20 initiatives is the MedEffect Canada
21 Initiative. And that consists of, we do have
22 the MedEffect Canada website, and that's both

9 reporting there as well.

10 An important aspect as well is the
11 MedEffect E-Notice. So, that's our list-
12 serve, where we're actively, proactively
13 sending stuff right out into the hands of
14 Canadians. And we're quite pleased that it's
15 a subscription over 18,000 subscribers to that
16 list-serve. A little smaller scale than on
17 the U.S. but we're pleased with that.

18 Another initiative just to share
19 with you. We have, in the branch, set up an
20 expert advisory committee on vigilance of
21 health products. And they're to have their
22 third meeting coming up the end of September,

1 and examining risk communications is one of
2 the items within their mandate. So, we're
3 quite interested to follow the discussions of

8 So, as I said, we have similar
9 challenges to those that you heard yesterday
10 from the centers. We see Health Canada as one
11 player in the healthcare system. We don't do
12 everything, and we can't do it all ourselves.

14 Canada, and the practice of medicine is
15 outside of our federal jurisdiction. And that
16 can bring challenges when you're getting into

8 themselves, it's how we distribute them, and
9 that's both our primary distribution but also
10 there's a number of different ways of
11 secondary distribution that I don't think
12 we've look adequately at in terms of how we
13 could use our, and work with, our healthcare
14 organizations and consumer and patient
15 organizations to better get our messages out.

16 And the third is the uptake. So,
17 not just enough to say we sent 200 things out,
18 but was it received, was it understood, did it
19 result in any change in practice. And that's
20 easier said than done. And we're again, quite
21 interested to hear what the ideas are around
22 examining effectiveness. Because it can be a

11 single topic. So things like, you know, on
12 the pet food, or on the Heparin, when the
13 situation is unclear at the front end, when do
14 we come out with information and what
15 information is helpful to share at what
16 stages.

17 And just lastly, we're also very
18 interested in the issue of relativity of risk,
19 or how do we best put risk into context for
20 Canadians. And again, these are not simple
21 questions. If they were simple, we would have
22 solved it on both sides of the border and just

2 So, again, I'm pleased to be here
3 as an observer at your meeting and we really

2 They, themselves, have good
3 relationships within their own organization.

8 like NAPRA, who are the National Pharmacy
9 Regulators, who will take our e-notice, and
10 also share them with their groups.

11 So, there's a full range of
12 secondary distribution that's effective. But
13 also, we do get on-going feedback from them on
14 our -- for example, when we're developing
15 guidelines on risk communications. They're
16 input is extremely helpful to us. Again, to
17 bring that practical perspective.

18 CHAIRMAN FISCHHOFF: Okay. Thank
19 you very much. And our second speaker is
20 Jeffrey Secunda from AdvaMed.

1 a trade association that represents the
2 medical device industry. And I want to give
3 my compliments to the committee and to the FDA
4 for their participation. It's been very
5 insightful and I think in some ways, in a very
6 positive way, provocative discussions.

7 I hadn't intended to say anything,
8 but again, the discussion was interesting and
9 provocative. And I do want to make three
10 points. The first is, I believe Ms. DeSalva's
11 prevention was marvelous in describing the
12 best practice of corporate response to crisis
13 and risk communication. However, I also want
14 to point out that -- and I believe that Lynn
15 Rice from FDA pointed out also -- that 75
16 percent of the medical device industry is
17 made up of small manufacturers, with as few as
18 30 or less employees.

19 And whereas, the portrait that was
20 portrayed is absolutely the pinnacle, it is
21 absolutely beyond the means of the vast
22 majority of manufacturers. And I think this

1 just goes to, you know, reinforce the
2 necessity for effective risk communication and
3 that it starts at the lowest level, goes to
4 the highest level.

5 And the second point I would want
6 to make in that regard, in reference to Dr.
7 Paling's concept that the FDA has a
8 responsibility to shape the communications: I
9 think this is absolutely a key point. And I
10 would direct this to FDA. The FDA mission is
11 well-known, is to protect and to enhance the
12 public health.

13 And I think that the effective risk
14 communication is the absolutely integral part
15 of that process. When it comes to FDA putting
16 out the message, that's important. But as
17 we've been hearing time and time again, and as
18 citizens of the media age, we all know that
19 the real communication doesn't take place --
20 doesn't come necessarily from the source of
21 the information, but rather from the
22 transmitters of that information.

1 And I think that FDA should take a
2 special responsibility in training the media
3 as to what FDA means, what are the terms mean,
4 what are the relative priorities and risks,
5 and this can't be a casual thing. This has to
6 be part of the core mission of FDA, in
7 enhancing and protecting the public health, to
8 be able to have effective partnership with the
9 media to get a real message out.

10 And I would also say that in
11 addition to the media, the financial community
12 is, I think, not necessarily well-understood
13 as being a very, very important communicator
14 of information. When there's a crisis that
15 goes out, you know, you might read about it in
16 the newspaper and run around and say, "Oh, my
17 gosh."

18 But, if you're an investor and
19 there is a crisis statement that goes out,
20 then that's going to have a material effect on
21 you and therefore, the financial community is
22 a critical part of the dissemination of this

1 risk communication.

2 And finally, I want to refer back
3 to the statement that Dr. Maisel made
4 yesterday, representing the Heart Rhythm
5 Society. And AdvaMed is completely in concert
6 with Dr. Maisel's presentation in terms of the
7 term "recall." I think that it's a barrier to
8 effective communication. And I -- and
9 honestly, I -- all the metaphors that we've
10 heard and means of communication, I had in
11 mind a particular metaphor for the concept of
12 the term "recall."

13 And that is, if you have a bump in
14 the sidewalk, and you want to warn people not
15 to trip on it, then if you put a barrier up
16 that covers the sidewalk, then you have an
17 option of either going around by stepping into
18 the street, or you can walk around, up on
19 private property. And the fact of the matter
20 is, that very often, if it is in fact a bump,
21 then you don't need a barrier to prevent
22 people from passing over it. You can put up a

1 warning sign. And I think that's, when all is
2 said and done, the term "recall" might be part
3 of the FDA lexicon, and it might have some
4 legal ramifications. But that doesn't mean
5 that it can't be changed, either from a legal
6 perspective in regulation, or very
7 practically, in the nature of the way that FDA
8 communicates and uses that term.

9 Instead of putting the recall in
10 red letters in a box on the paper, it can have
11 urgent safety notification, which are very
12 communicative terms that are well understood.
13 And then if you have to put into the footer,
14 you know, pursuant to, you know, Part 7, is a
15 "recall."

16 It all depends on how it's framed.

17 And I just think that it's a unnecessary
18 impediment to effective communication. Thank
19 you.

1 recommendations for FDA. We have particularly
2 in our two talks today, we had a number of
3 quite concrete proposals.

4 Let me just direct your attention.
5 This will be in the folder for all of the
6 committee members. I guess it would -- I

9 So, we have four questions here.
10 Rather than read them, I'll allow them, just
11 sort of take a look at them and see some of
12 the classes of recommendation that we might
13 come up with. But we're also free to think of
14 other -- of other things.

15 So, let me, before -- to kick this
16 off, let me -- I'd like to make a comment,
17 some sort of "to connect" comments that David
18 and Musa and Ellen and some of the others
19 made just before the break. So, I think we've
20 had -- I have to make certain that a half an
21 hour doesn't go by without talking about
22 evaluation. But I think we've had an hour go

2 And so let me say I think that, so
3 the question of how do you deal with evidence
4 -- I mean, we have common sense evidence. You
5 know, sort of every day evidence of people's
6 difficulty with numbers. We have a growing
7 research literature about forms of innumeracy
8 and its correlates, and its extent. We see
9 that there's -- that we're sort of dead in the
10 water if people don't know how large the risks
11 and the benefits are, and how good the
12 evidence are.

13 And so how do we reconcile that?
14 And I think that a necessary, but not
15 sufficient condition is to have as part of the
16 research group, people who are intimately
17 familiar with the research literature. It
18 gives you a few things. One, is it gives you
19 access to whatever else is out there.

20 So, you see, we have several
21 experts here, and we're checking with one
22 another, whether or not you've heard of

1 anything. So, if you've read a few papers,
2 you've just seen a tip or less than a tip of
3 the iceberg of what's out there. So, you want
4 access and you want people who can call up
5 other people who can bring that in.

6 And without people who are trained,
7 there's really no way that that can happen.
8 And they have to be there, you know, in real
9 time as the projects are being developed, you
10 know, in the same way that you need your
11 collaborators to be there in real time to see
12 where you've gone astray.

13 Second thing that people who are
14 familiar with the research literature can give
15 you, is they can give you the context for
16 understanding the research that you're seeing.

17 So for example, a standard technique,
18 particularly in psychology, is to create
19 conditions that magnify biases. That is,
20 much of psychology is built on finding ways in
21 people, in which people make mistakes.
22 Because those tell us something about the

1 systems in which -- that generate their
2 behavior.

3 So, if you think about -- a lot of
4 perception research has been informed by
5 optical illusions, because it shows you things
6 you wouldn't already see. The fact that you
7 can generate reliable, theoretically
8 informative optical illusions, doesn't really
9 tell you that much about how good people's
10 perceptual systems are in everyday life. And
11 a perceptual system, you just don't know how
12 often we're challenged. You don't know what
13 kind of prosthetics we've developed, or aids
14 we've developed to overcome things, how we've
15 engineered our surroundings so that they don't
16 mislead us.

17 So, one needs people who know the
18 literature, who can tell you whether, you
19 know, this is a robust, theoretically
20 informative experiment, hothouse phenomenon.
21 We can show you problems, but they may --
22 sometimes they're big, or sometimes they're

1 not. You really need somebody who knows the
2 literature and will look at it candidly.

3 And I would say that people, as one
4 of them, you know, people who scientists are
5 totally enamored of their phenomena, and we do
6 tend to get carried away with the importance
7 of whatever we study. And if we study biases,
8 we see biases all the time. They're really
9 robust to us. And people look -- can look
10 terrible if we don't catch our breath and
11 think about the context within which they are.

12 Second thing, something that we --
13 the behavioral researchers can't do by
14 ourselves, is to understand the sensitivity of
15 the context to the kinds of problems that we
16 have. So we can give you a best estimate of
17 you know, a lot of uncertainty, but imagine we
18 can give you a best estimate of how numerate,
19 how well people are going to be able to
20 process quantitative information in a setting.

21 You, who know the, you know, the
22 experts and the decisions will tell us whether

1 or not that's good enough. You know,
2 sometimes the gist will get you to the right
3 answer, and sometimes you need really precise,
4 precise information. So you need not only to
5 have the people who know the research, but to
6 have them in a context that will discipline
7 them.

8 The third thing is that you need
9 people who know the research to tell you how
10 good -- whether people have been given -- how
11 good the communications have been. So, people
12 can perform badly because they've gotten lousy
13 communications. And you know, as I guess
14 Ellen began her talk, we all believe that we
15 all exaggerate how well we're communicating.
16 It applies to me right now.

17 We all exaggerate how well we're
18 communicating. So, we put out a message. It
19 makes sense to us, and if people don't
20 understand it, we think, "oh, they're
21 innumerate, they have low health literacy,
22 they just can't handle it." So, you need

1 -- you need to be, need to look hard to see
2 whether the problem is with the receiver, or
3 with the transmitter. And you know, you
4 really need the expertise. You need the
5 empirical evidence of evaluation, but you also
6 need people who have that kind of expertise.

7 And then finally, you need -- if
8 you find the situation where individuals are
9 not, you know, you've given it -- you're in a
10 situation where you've used the best of the
11 science to produce the communication that will
12 provide the information that's essential to
13 people's decisions, and people can't reach the
14 level of proficiency that you would like for
15 them to give informed consent for whatever
16 product there is, that they're being asked --
17 decision they're being asked to make, then
18 you need to think about, what's the system
19 within which those people are embedded?

20 So that is, maybe I can't
21 understand the, you know, the financial
22 disclosure that I get from you know, my

1 pension plan. But am I one or two degrees of
2 separation from somebody who can decode that
3 for me? Or, if I can't understand Medicare
4 Part D -- the 50 firm by 80 option matrix
5 that's been created for me -- am I within one
6 or two degrees of separation for somebody who
7 can do that?

8 And for that, you need somebody,
9 say like David Moxley who's not here today,
10 who understands the social context within
11 which people actually make decisions, to see
12 whether you can engineer it. So, we're in big
13 trouble. Medicare Part D maybe one of those
14 examples, where nobody is within the ball park
15 of anybody who can make any sense out of it.

16 But I think that with a lot of
17 situations, you know, as Musa was saying, if
18 you can get the quantitative risk and benefit
19 information that people need -- they've got a
20 friend, they've got a confidant, they've got a
21 physician, they've got an interpreter within
22 the medical press who can make that

1 comprehensible to them. So, I thought your
2 point was very well-taken, and we require good
3 research and a systems approach to get as far
4 as we can in expanding people's envelope of
5 competence. And then, you know, being ready
6 to help them where it's too much, or to find
7 people who will help them.

8 So, let's -- Marielos.

9 MS. VEGA: This question is for
10 Nancy. Is there a regulatory issue for the
11 FDA not to accept help offered? For example,
12 when we were talking about having the students
13 at universities help in the FDA with the
14 research agenda, is there a regulatory issue
15 in accepting the help freely?

17 don't think it's a -- actually with FDA, there
18 may be regulatory issues. It depends on who
19 the help is coming from. Okay? Because there
20 are sources that are allowed, and sources that

1 source that we regulate, like industry.

2 And there are all kinds of
3 regulations that are not necessarily FDA
4 regulations, but are government regulations
5 that kind of go around the ethics and the
6 conflicts of interests, and the appearance of
7 conflicts of interests. So, we have a whole
8 ethics group, you know, that is there to help
9 us kind of navigate those waters.

10 So, I can't give you a real solid
11 answer on that, except to tell you that, you
12 know, that's my general sense. Lee probably
13 has more about -- knows a little bit more
14 about this than I do.

15 MS. ZWANZIGER: And I would just
16 say, that it -- as Nancy suggested, it would
17 depend a lot on what the details are. I
18 wouldn't -- I would say, it's always worth
19 bringing up a specific case to think about so
20 that we can get some more specific answers.

1 line. I just wondered if through the IPA, and
2 I forgot what that -- Interpersonal Government
3 Act, that governs exchange or details a
4 personnel from the agency to other

6 you can receive experts from academic

8 agencies. I think that's still in effect.

9 I wondered if you could accomplish
10 some of this with maybe not necessarily
11 students, all right, well, probably still
12 students, through the academic institutions,
13 if you could -- if this could be governed
14 through the IPA, where you could bring in
15 experts from academic institutions to work on
16 some assignments?

20 or so. I believe that Craig Andrews, for
21 instance, worked on an IPA with the Federal

9 Division of Drug Marketing, Advertising and
10 Communications on research they're doing. And
11 I believe Anna Mitra, also from American, is
12 working with the foods group. So we do have
13 the capability. Those people then become
14 special government employees, though. And
15 then, they're kind of separate, in terms of
16 from their organization.

18 someone who can -- I mean, in some ways, they
19 can come in, and then they can go back out
20 again. And then do stuff that they know is
21 helpful, you know, within the context of their
22 academic positions. So, there are different

5 is that we -- and that should be part of a

7 how to get that external expertise in for
8 specific projects, or for specific time
9 frames. And we'd be very interested in
10 talking with any of you who are interested,
11 you know, or have people who are interested in
12 doing that kind of thing. Because as Lee
13 said, we need the details in order to figure
14 out how to work things out.

16 that if there's -- we would hope -- increasing
17 demand for people who can do that kind of work
18 within FDA, having somebody work here and then

9 variations, so you have to take those into
10 account when you produce a final document like
11 a press release or any of the other documents

14 this is a solvable problem. Again, it's a
15 strategic issue. But, that I have not seen
16 this in the agencies that I've been involved
17 within in the federal government, I have not
18 seen any of them address this problem in a
19 really effective way. And I've only been
20 involved with health-related agencies, so
21 others may have done this well.

1 solvable without a lot of money, and two
2 things are needed. One is, either internal
3 again, hiring. Hiring a person who is

6 up a process for dealing with linguistic
7 variations. And I don't want to go into
8 detail about that right now, because it would
9 take time. It is a strategic issue. But
10 there are ways to bring into concert the
11 people with skills in -- let's say, across
12 various Spanish linguistic variations, and
13 produce a neutral Spanish document without a
14 lot of problems and expense.

15 But it would take a process that's
16 put into place. So, wanted to recommend that.

17 And I think it would be great if
18 the FDA took leadership on solving a problem,
19 and then becoming a model for other agencies
20 on how to do this. Like I say, you have so
21 many problems that are so complex, this is one
22 you could deal with, at least in Spanish, and

1 relatively quickly, I think.

2 I know the hiring -- new budget

6 The other is, I wanted to ask --

1 lot of cases. In my own, strictly personal
2 experience, I've had very good experiences.
3 And I think that that has a lot to do with the
4 kinds of organizations I've worked with, with
5 the quality of the people I've worked with,
6 with trust. Trust is very important. And I
7 think when there's you know, prior working
8 relationship and kind of people are known to
9 each other, it makes things a lot easier.

10 But you know, I know that there's
11 room for improvement. And so, I do think
12 there is, if Heidi had been able to stay, it
13 would have been wonderful to have this
14 exchange with her. It is to understand, what
15 should best practice be? What should the
16 state of play between the agency and industry
17 when communicating around emergent risk,
18 around, you know, major events.

19 And I don't think that's been well-
20 defined. I think it's very much a work in
21 progress. I think that there's a lot of
22 opportunity to get the right people together

1 to explore that very issue and define what
2 best practice is.

3 I mean, I think with respect to the
4 case I presented, it's a nuanced point, but
5 nonetheless, a very deliberate point, that
6 when you consider that moment in time when
7 it's time to take the field action, you'll --
8 and if you remember, the sequence of events is
9 such, that the strategy is basically baked
10 before the company communicates it to the
11 agency.

12 And there's several points in that
13 time line, in which there's very substantial
14 exchange with the agency in terms of the
15 investigation, in terms of the letter that
16 goes out to surgeons to describe the
17 investigation. I think technically that
18 letter, because it talks about adverse events,
19 adverse events, and talks about
20 investigation, I think technically that's a
21 recall. I don't -- Nancy, I don't know.
22 Maybe you would advise differently. But I

1 think that, according to the regulations,
2 "recall" is a broad term.

3 In the medical devices world it
4 actually does relate to any change,
5 correction, you know, or change in
6 notification about adverse events experience.

7 But so there are several points in time where
8 there would be very significant exchange with
9 the agency. But when it's time to actually
10 initiate the field action, and mobilize all
11 those risk communications, you know, a company
12 may feel like it's really important to have
13 everything basically ready for execution.

14 And the reason for that is, by the
15 time that exchange occurs, it's going to move
16 very rapidly. And there may be reasons to
17 revisit that. I mean, in certain situations,
18 it may be wise to stage the communication or
19 to be able to have a window of opportunity to
20 you know, communicate with surgeons first,
21 before a broader public communication happens.

22 I think those questions are on the

1 table. It's like, how do you get to the right
2 outcome? What's the best way to get to the
3 best outcome? And I'm sure that there's a lot
4 of discussion that that could occur around
5 that.

6 So, I don't know, you know. I
7 think that there are always opportunities
8 between the private sector and the public
9 sector to exchange best practices. And I
10 think that I've always greatly enjoyed my work
11 in the public sector and I've taken many of
12 those lessons with me into the private sector,
13 and vice versa. So, you know, I think that
14 resources being different, circumstances being
15 different, it isn't always apples to apples.

16 But I'm sure that the commitment to
17 preparedness, I think, is to answer your
18 question more directly, is paramount in
19 communication. There is -- you don't always
20 know what you're dealing with. But if you can
21 anticipate to some extent what you're dealing
22 with, you know, 80 -- 70 or 80 percent of what

1 you need to do can be started, you know, well
2 in advance. And that means the quality of
3 your communication is going to be that much

6 So, those are just some thoughts in
7 response to your question.

9 could followup on that. How do you make --
10 maybe you've just done it, but so how do you
11 make the business case you know, that in terms
12 of the, you know, there's a public rather than
13 a private firm, that the business case that it
14 is, you know, the agency's -- it's products,
15 it's product is the protection of the American
16 -- protection of the health of the American
17 public --

7 successful in making the case.

8 MS. DESALVA: Sure.

10 of your strategies for that strategy?

11 MS. DESALVA: Your -- it's an
12 incredibly relevant question. And there --
13 earlier in my career, I'm not so old, but I'm
14 old enough to go back far enough to think
15 about the times when communication wasn't that
16 central in the industry, or it was sort of a
17 peripheral discipline. Or, it was -- if it
18 wasn't peripheral, it was thought of second,
19 or third, or fourth or fifth in the process.
20 And you know, I see a change where it's
21 thought of first, and it's really prioritized.
22 And it's because the industry for the most

1 part, understands how central it is to the
2 business.

3 So, the way that those cases have
4 been made, have a lot to do with failure.
5 Have a lot to do with just, you know, painful
6 experiences where you know, there's been undue
7 risk and pain and suffering in many different
8 ways, either to patients, or to the business
9 and to corporate reputation.

10 So, the equivalent, if we think
11 about it, from FDA's perspective, I mean, for
12 the agency to have some wild successes and to
13 be able to clearly demonstrate the power and
14 impact of its communication in terms of
15 protecting the public safety and health, and
16 interest, and to be seen as you know, just
17 very effective agent for that kind of change
18 and a partner, you know, to the private in
19 managing major risks, would be very powerful.

20 And it's why I asked some of the
21 question. I mean, we're all asking questions
22 about evaluation. I know it gets very

1 tiresome, because we all know what the
2 challenges are there. But especially this
3 area of emerging risk communication, I just
4 think for the agency, if somehow it were
5 possible for the agency to blase a trail
6 there, and to really make that a priority and
7 say, you know what, we are in a new age of
8 transparency and accountability in
9 communication.

10 And there is going to be much more
11 emerging risk information. And we're not just
12 going to you know, put it out there and allow
13 all the downstream effects to occur. We're
14 going to proactively manage it, and we're
15 going to demonstrate and show, you know, how
16 we can contextualize it, and help a variety of
17 stakeholders interpret that risk and use it in
18 an intelligent way, and really minimize the
19 potential disruption it can cause.

20 And then, we're going to describe
21 that and in such a way that you can advance
22 knowledge and practice. And that becomes

1 broadly valuable to other parts of the
2 government and then also certainly to the
3 industry.

4 But you do need some experience and
5 some data I think to be able to do that. To
6 be able to demonstrate the value, otherwise,
7 it's vague. And I think on the industry side
8 of things, I think that's -- they were just
9 very tangible experiences and data that have
10 allowed these best practices to develop.

11 MR. SMITH: Baruch, if I can share
12 some personal experience. Because in a couple
13 of different companies that I've been with, we
14 had the situation where we weren't prepared.
15 And in my role in heading up quality, that, I
16 felt like that sort of fell in my area. And I
17 think the same rationale and policies would
18 hold true for FDA.

19 And it really is, look at it as an
20 insurance policy. Because that's what it is.
21 Because it's going to happen. It's going to
22 happen on a Friday afternoon at 5:00 o'clock.

1 And if you're not prepared, it's going to be
2 much worse.

3 And if you go and look at case
4 studies, and see which companies were
5 prepared, or which agencies were prepared, and
6 which ones weren't you know, time and again,
7 you see people sailing through it, in the
8 classic historical one is Tylenol when they
9 had that horrible contamination. And you
10 know, they handled it perfectly well. And
11 that's sort of the state-of-the-art.

12 And then there's many cases of, and
13 I'm sure AnnaMaria has many more, of just
14 disasters where leading to some companies
15 going out of business for some things that
16 just weren't handled very well. So, you know,
17 between looking at the case histories of what
18 preparedness can do for you in making a
19 difference of survival or not, and looking at
20 the philosophy of, it's an insurance policy,
21 when you look at it, it's a pretty cheap
22 insurance policy.

1 It is a pretty easy case to make
2 when you're talking to rational people.

3 MS. DESALVA: It really is.

4 MR. SMITH: So, there are ways to
5 do it.

6 MS. DESALVA: I've had some
7 experiences with some smaller clients, you
8 know, clients who don't have lots and lots of
9 resources, or who maybe are earlier on the
10 curve of applying best communication practice.

11 And you know what can be challenging, is that
12 when you -- in working in that environment,
13 you know, your reward is, what doesn't happen.

14 So, you convince people to invest,
15 to spend the time and effort to have a high
16 level of a state of readiness, to implement
17 certain strategies and tactics that are great
18 insurance policy. And then your outcome is,
19 you averted a problem. And that's a challenge
20 in answering your question, which is, how do
21 you make the business case. It's -- you
22 probably do need to do some side-by-sides of

2 readiness compared to what happens when you do

6 MS. PETERS: I was going to

9 MS. PETERS I'm curious what you
10 think, and maybe what some other people, Dr.
11 Smith, and maybe Dr. Ostrove think as well,
12 about communicating on-going risks, versus
13 communicating emerging risks. What are some
14 of the similarities, and what are some of the
15 differences?

17 because in some cases, improving our
18 communication about on-going risks, will
19 probably also help our communication about
20 emerging risks. But there are also some
21 differences and probably some very important
22 key differences around time. But I'm curious

2 similarities and differences?

3 MS. DESALVA: I think it's a great
4 point. And it's one that I've alluded to a
5 couple of times. You know, when you have like
6 an on-going situation to manage, which the
7 industry often does. I mean, all of these
8 products have risks. Some of them have a more
9 grave you know, risk-benefit profile than
10 others.

11 And I think that's the opportunity
12 to probably do the most thoughtful work. And
13 I think that's where oftentimes, sort of the -
14 - a lot of the theory and principles and
15 strategies that we've discussed in these
16 sessions, that's where the opportunity is, I
17 think, for the industry to mine those even
18 more than they currently do, and apply them
19 over a longer time horizon, and to understand,
20 or describe what their impact is.

21 You know, the industry is trending
22 in many cases, towards risk first

1 communication. I think that the industry is
2 finding its way very much now in sort of
3 shifting the paradigm of how it communicates
4 and markets products. And in certain
5 categories, the pendulum has swung all the way
6 to risk first communication. And where the
7 emphasis is on making sure first that the
8 target understands the risk profile, and
9 discussion of benefit really happens strictly
10 within that context or as a secondary or even
11 tertiary you know, message.

12 And that tends to be in categories
13 where there's been very visible or difficult
14 risk issues. So, I think that there's you
15 know, a lot of progress being made there. The
16 difference, obviously, does tend to be
17 circumstantial. So, I think that moving those
18 practices and it's why I referred earlier to
19 the best case scenario, you have -- when you
20 get into tough situations like the case I
21 presented, you already have a repository of
22 knowledge. You've prior experience from the

1 on-going work you do in less acute situations.
2 And you have those relationships in place that
3 you can draw from.

4 But the circumstances are very
5 different with emerging risk. And I don't
6 think best practice in emerging risk
7 communication has been defined. I think that
8 -- and I'd invite other people to comment who
9 may know more on this subject than I do. But
10 I think that that's a big priority both for
11 the agency and for the industry. And it has a
12 lot to do with what others and with what
13 John's talked about earlier about providing
14 context and making sure that people understand
15 what an emergent risk is, and what it's not.

16 And so I think that the opportunity
17 to educate there, and to educate at the level
18 of influencers and people who amplify
19 communication, like the media, you know, and
20 other key people, and the advocacy community
21 and certainly in the professional community,
22 so that emerging risk can be interpreted.

20 are some simple things that can be done. Here
21 are some things that we can think about and
22 that we need to do more research on, and here

9 that we don't have that yet. I don't think
10 anyone has that yet. And to the extent that
11 any kind of best practices, or good practices
12 or you know, some practices that have at least
13 some empirical basis, that we can bring to our
14 centers, to the rest of the agency, is exactly
15 what we're looking for.

1 similarities and differences between ongoing
2 risks and emerging risks, is that you can
3 start with sort of a base of knowledge that
4 you can build up in a more thoughtful way when
5 you're looking at on-going risks. And that's
6 a lot of what we've talked about today.

7 Then, what's different in terms of
8 the emerging risk profile has to do with the
9 circumstances in the moment, which include
10 really important timing issues and things like
11 that. But those circumstances are often
12 surprises. So at that point, how do you come
13 up -- how do you prepare? You talked a lot
14 about having a preparatory strategy for this.

15 Other than the base knowledge that you can
16 come up with, how do you prepare for
17 circumstances?

19 case scenario, you know, there is enough
20 surveillance, there are enough systems in
21 place that you are aware -- you kind of know
22 what you don't know. You have a sense of what

1 could happen. Not because you have foresight
2 into specific safety issues that are going to
3 happen in the future, but because you know
4 your business well and you know the nature of
5 the challenges and of the risks that are
6 fundamental, you know, to the business.

7 There's a lot of very incredibly
8 rapid work in the moment that happens. And it
9 comes together very quickly. And that's why
10 in healthcare communication, you know, it's a
11 little bit like being a firefighter. Because
12 you do get into these situations where you
13 have to extremely quickly, assess and collect
14 the right knowledge, and then consolidate the
15 right strategy. And it's not perfect. And
16 it's not, you know, you can apply all of these
17 principles and methodologies that have been so
18 well developed by the experts.

19 You have to hopefully have a base
20 of knowledge there, and then do what's very
21 practical in the moment. And put it together,
22 you know, very rapidly. So, in my own

1 personal experience, and I did mention this
2 when I presented, I mean, I have kind of a
3 short list of people I know and trust. Some
4 of them are in my own organization, some of
5 them will be in my client's organization.
6 Some of them are external experts. And when
7 things are really breaking fast, and you know
8 that the communication if its not right can be
9 a big problem, it's a very consultative
10 process. And you just consult as rapidly as
11 you can, and use your professional judgment
12 and your prior knowledge.

13 But then also, be ready to course
14 correct. I think that's very important. So,
15 if you communicate about something and your
16 best efforts can still be a problem, just one
17 or more stakeholders. And then you have to be
18 able to shift and correct. So, it's fluid.
19 And you know, it -- there's a lot of judgment
20 involved, I think, professional judgment
21 involved in -- did you? Sorry.

9 understanding, you know, what people's
10 rational and emotional needs are, and how they
11 react in certain circumstances. And that data
12 doesn't always exist, but you're lucky when it
13 does and you should use it if you've got it.
