The purpose of this modification is to provide incremental funding in the amount of **\$31,532,816.00**, this includes \$200,000 Guatemala MAARD funding and a \$100,000 West and Central Africa MAARD. The added funding will increase the total obligated amount from **\$40,028,988.00** to **\$71,561,804.00**. The total cost of the Agreement is **\$147,500,000.00**. The amount remaining to be obligated is **\$75,938,196.00**.
