# **Certifying Public Financial Disclosure Reports**

## **Course Description**

This course focuses on the knowledge and skills new reviewers need to complete a review of the Executive Branch Public Financial Disclosure Report (SF 278). The course examines how to review the reports for technical accuracy and identify potential financial conflicts of interest. The course also addresses how to determine the best action to resolve various types of financial conflicts.

You have the opportunity to practice reviewing and analyzing a fictitious SF 278 with entries similar to those from a typical filer. Class format includes lecture, discussion, and hands-on exercises.

#### **Intended Audience**

Ethics officials and other agency personnel who review and assess employees' public financial disclosure reports and are new to the review process

## You Will

- o Identify information filers must report in each schedule of the SF 278
- Conduct a technical review and conflict of interest analysis of each entry
- o Identify appropriate remedies to resolve conflicts
