# **Certifying 278 Reports**

This course focuses on the knowledge and skills new reviewers need to complete a review of the Executive Branch Financial Disclosure Public The course Report (SF 278). examines how to review the reports for technical accuracy and identify potential financial conflicts of interest. The course also addresses how to determine the best action to resolve various types of financial conflicts.

You have the opportunity to practice reviewing and analyzing a fictitious SF 278 with entries similar to those from a typical filer. Class format includes lecture, discussion, and hands-on exercises for each schedule of the fictitious employee SF 278.

# Conflicts of Interest/Impartiality

This course covers the specific provisions of 18 USC section 208, dealing with acts affecting a personal financial interest. It isn't enough that employees avoid conflicts of interest under 18 U.S.C. 208. They must also avoid even the appearance of a conflict of interest. This course will also examine the various factors that ethics officials should consider when determining whether a reasonable person would question an employee's impartiality.

#### **Gifts**

This course explores the inherent pitfalls when Federal employees receive gifts from outside sources. We will define what a gift is, and identify the general gift standards and exceptions. Attendees of this session will be able to differentiate the categories of gift exceptions and determine the circumstances under which they may be used.

## **Financial Disclosure**

This course provides participants with an overview of the confidential financial disclosure reporting requirements. Participants will learn how to review each part of the OGE Form 450 for conflicts of interest and technical accuracy. The course will conclude with an in-depth review of a sample OGE Form 450 where participants will apply learned concepts to common conflicts and technical issues.
