Subject: FSH 5109.17 Letter Clarification

To: Regional Foresters and Area Director

This letter serves to clarify the direction issued in the June 19, 2000, letter signed by Janice McDougle regarding wildland prescribed fire and fire use position requirements as outlined in FSH 5109.17. The FSM 5140 and FSH 5109.17 will be reviewed after one year in effect to address regional concerns. If you have input, please submit the information to your Geographical Area Training Representative for discussion at their November 2000 meeting.

The following guidance and revisions to FSH 5109.17 are effective immediately:

Type 4 Incident (Initial Attack) - Chapter 20, page 7, paragraph 2a:

Remove:

"An experienced and qualified Advanced Firefighter (FFT1) may be designated as

Incident Commander."

Fire Use Manager (FUMA) - Chapter 20, page 95:

Individuals who have the prerequisite experience of RXB1 and have either (1) successfully managed a wildland fire use incident within two years of the effective date of FSH 5109.17 or (2) managed a wildland fire use incident and successfully completed S-580 or equivalent course may be certified as qualified in the FUMA position at the discretion of their Fire Qualification Review Committee. Qualifying experience must include full demonstration and understanding of policy changes and use of the WFIP planning process.

Prescribed Fire Planner (RXPL) - Chapter 20, page 96:

Individuals who have successfully prepared a complex (Type I) burn plan, which has been reviewed and approved by a qualified RXB1, within two years of the effective date of FSH 5109.17 may be certified as a qualified RXPL at the discretion of their Fire Qualification Review Committee.

Prescribed Fire Burn Boss Type 3 (RXB3) - Chapter 20, page 98:

Individuals who have the prerequisite experience of FFT2 with three or more wildland fire or prescribed fire assignments and local knowledge of fuel and fire behavior (reference FSM 5140) may be certified as a qualified in the RXB3 position at the discretion of their Fire Qualification Review Committee.

Subject: 5109.17 Fire and Aviation Management Qualifications Handbook

To: Regional Foresters

The Fire and Aviation Management Qualifications Handbook (FSH 5109.17) has been issued with an effective date of May 18, 2000. This handbook serves as the primary position qualification requirements guide for Forest Service employees. FSH 5109.17 supplements the Wildland and Prescribed Fire Qualification System Guide, PMS 310-1, that provides national minimum requirements for wildland firefighting personnel. It also describes more specific skill levels and lists additional training to meet agency specific requirements.

Many of the handbook updates are associated with the Forest Service determination that additional classroom training is more effective in preparing Forest Service employees for position assignments. These training standards meet or exceed all National Wildland Fire Coordinating Group agency standards. As with the other agencies, the successful completion of a position task book is the primary indicator of qualification.

FSH 5109.17 is designed to establish a single qualification standard for the Forest Service. Regional Foresters can supplement fire and aviation management qualifications requirements only to comply with State or local law. Examples of State and local compliance include requirements related to first responders or hazardous materials. Additional experience, fitness or training requirements for position qualifications are inappropriate. Physical fitness requirements for prescribed fire qualifications may be increased through a job hazard analysis. Please review the document in its entirety and implement it on your units.
