WHO MAY APPLY FOR TEMPORARY POSITIONS: Applications will be accepted from most anyone if the position is temporary and will last one year or less. Applications will also be accepted from Indian Preference applicants if the appointment will be made in excess of one year. Non-Indians may apply for term positions provided he or she has status and the appointment can be made in the competitive service. DUTIES AND RESPONSIBILITIES: The position is in the Clinical Services/Section of the Quentin N. Burdick Memorial Health Care Facility, Belcourt, North Dakota. The incumbent will provide direct and comprehensive primary, preventive and therapeutic medical care to individual geriatric, adult, adolescent, pediatric and infant patients and their families. Takes a complete health and developmental history from the patient and/or family member and performs a physical examination of the patient using palpation, percussion, auscultation, observation skills, using appropriate diagnostic instruments. Orders and/or performs screening and diagnostic tests and procedures. Interprets test results and analyzes all collected data, discriminates between normal and abnormal findings to identify all stages of serious physical, emotional or mental problems, and to prioritize health care needs. Seeks to obtain and maintain competency of Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), and Neonatal Advanced Life Support (NALS), in order to accept emergency room assignments on an intermittent or scheduled basis. Maintains and improves professional knowledge and skills by participating in seminars, accredited home study, in-service education and/or individualized preceptor ship. Maintains current clinical competence through self-study, review of professional journals and tapes, etc.

**QUALIFICATION REQUIREMENTS:** Candidate must meet qualification standards as specified in **OPM Operating Manual** (Qualification Standards for General Schedule Positions) and/or the Excepted Service Qualification Standard:

GS-07: One year of specialized experience equivalent to least the next lower grade level.

### **Basic Requirements:**

A broad background of knowledge of the medical environment, practices, and procedures such as would be acquired by a bachelor's degree in a health care occupation such as nursing, medical technology, or physical therapy, or by 3 years of responsible and progressive health care experience such as medical corpsman, nursing assistant, or medical technician; and successful completion of a certificate or diploma program of at least 12 months, including clinical training or preceptorship, specifically designed for professional-caliber physician's assistants that provided the knowledge and ability required to take a detailed medical history, to conduct a physical examination, to follow observation procedures, to order and perform diagnostic and therapeutic tasks, and to exercise a degree of judgment in integrating and interpreting findings on the basis of general medical knowledge; or equivalent education and training.

OR

Successful completion of a full 4-year program for physician assistants leading to a bachelor's degree.

The course of study or training must be approved by a nationally-recognized professional body such as the Committee on Allied Health Education and Accreditation or the Accrediting Bureau of Health Education Schools, or by a panel of physicians established by a Federal agency for this purpose.

Applicants who meet the basic requirements qualify for GS-7.

## **EDUCATION**

Applicants who have completed 3 full years of a curriculum in an accredited medical school leading to the Doctor of Medicine or Doctor or Osteopathy degree may be rated eligible for GS-9.

Applicants who have completed the requirements for the degrees of Doctor of Medicine or Osteopathy, but who lack licensure to practice medicine in the United States, may be rated eligible for GS-11.

Applicants qualifying on the basis of specialized experience must have the following:

- Knowledge and understanding of the environment, principles, ethics, and special human relationships in the field of medicine.
- Knowledge of the medical, biological, and physical sciences related to the applicable area of medicine.
- > Knowledge of and ability to perform specified diagnostic and therapeutic practices and procedures.
- > Ability to work responsibly with physicians and other members of the medical team, and to deal effectively with patients.
- Ability to communicate effectively, both orally and in writing.

## **EXCEPTED SERVICE QUALIFICATION REQUIREMENTS:** Same as above.

- 5. Retired under the discontinued service retirement option; or
- 6. Was separated because he/she declined a transfer of function or directed reassignment to another commuting area.

#### OR

- B. Former Military Reserve or National Guard Technicians who are receiving a special OPM disability retirement annuity under section 8337 (h) or 8456 of Title 5 United States Code.
- 2. Be applying for a position at or below the grade level of the position from which you have been separated. The position must not have a greater promotion potential than the position from which you were separated.
- 3. Have a current (or last) performance rating of record of at least fully successful or equivalent. This must be submitted with your application package. (This requirement does not apply to candidates who are eligible due to compensable injury or disability retirement).
- 4. Occupy or be displaced from a position in the same local commuting area of the position for which you are requesting priority consideration.
