<u>DUTIES AND RESPONSIBILITIES</u>: This position is located at the Quentin N. Burdick Memorial Health Care Facility, Belcourt, North Dakota. This position will provide diagnostic, preventive, nursing and therapeutic health care services to patients and family members in a primary care facility under supervision of a physician. Provides medical care in accordance with approved standing orders. Initiates telephone consultation with or referral to a physician in cases, which exceed the scope of the standing orders. In unusual cases may function in the absence of physician preceptor on site. Discriminates between normal and abnormal findings to recognize early stages of serious physical, emotional, or mental problems. Initiates referral for in-hospital care or specialist consultation in cases, which exceed the health care capabilities of the Service Unit facilities and personnel. Provides surveillance over medical and nursing practices applied to stabilize chronically ill persons, adjusts treatment within established standing orders, recognizing when to refer the patient to a physician or other health team members. Provides health related information and anticipatory guidance to individual clients and families. Maintains records and reports on patients, personal activities and other required information for use in program operation, quality assurance wand other purposes.

QUALIFICATION REQUIREMENTS: Candidate must meet qualification standards as specified in **OPM Operating Manual** (Qualification Standards for General Schedule Positions) and/or the Excepted Service Qualification Standard, including IHS licensure policy:

Evaluation of Experience: Experience must have equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position. At the GS-09 and above, many positions require experience in a specialty area of nursing.
