**SUPPLEMENTARY INFORMATION**: This investigation was instituted on March 7, 2008, based on a complaint filed by Presstek, Inc. of Hudson, New Hampshire. The complaint alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain laser imageable lithographic printing plates that infringe certain claims of U.S. Patent Nos. 5,339,737 and 5,487,338 and U.S. Trademark Reg. No. 1,711,005.

On December 11, 2008, the ALJ issued the subject ID, extending the target date for completion of the investigation to November 30, 2009. No petitions for review were filed. The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
