INTRODUCTION

This Supporting Statement is submitted as part of a Paperwork Reduction Act (PRA) request to renew and revise an information collection that was approved under OMB Control No.: 0648-0327. The existing collection consists of mandatory annual vessel permits for commercial Atlantic tunas fisheries and recreational and charter/headboat fisheries for all Atlantic Highly Migratory Species (HMS) and a dealer permit (HMS International Trade Permit (ITP)) that is required for import or export of bluefin tuna, southern bluefin tuna, swordfish, and frozen bigeye tuna. Several HMS permits are being added to this collection to make this collection a comprehensive permit family of forms for Atlantic HMS fisheries, as indicated in the table below.

A. JUSTIFICATION

1. Explain the circumstances that make the collection of information necessary.

The purpose of this collection of information is to comply with the statutory obligations of the Atlantic Tunas Convention Act of 1975 (ATCA; 16 U.S.C. 971)(Attachment 6), the Tunas Conservation Act (TCA, 16 U.S.C. §955)(Attachment 7), and the Magnuson-Stevens Fishery Conservation and Management Act (MSFCMA; 16 U.S.C. 1853)(Attachment 8), and, the implementing regulations at 50 CFR part 635.

Section 971d(c)(3) of the ATCA provides the statutory authority to promulgate regulations as necessary to implement the recommendations of the International Commission for the Conservation of Atlantic Tunas (ICCAT). As a member nation of ICCAT, the United States is obligated to implement ICCAT recommendations and take part in the collection of biological statistics for research purposes (fishing effort and catch). As one of the member nations fishing for Atlantic HMS, the United States must abide by the specific catch quotas or caps assigned by ICCAT and support ICCAT rebuilding and fishery management programs. ICCAT recommendations have also established restrictions on international trade, such as statistical document programs to track the trade of bluefin tuna, swordfish, and frozen bigeye tuna.

The United States is also a member of the Inter-American Tropical Tuna Commission (IATTC), and authorized under the Tunas Convention Act to implement resolutions approved by IATTC. Like ICCAT, IATTC has adopted a resolution for a frozen bigeye tuna statistical document program.

The Atlantic tunas, swordfish, billfish and shark fisheries are also managed under the MSFCMA, and several of these fisheries are subject to restrictive catch quotas with the goal of recovering the stocks to a level commensurate with maximum sustainable yield. These stocks are fully fished or overfished at this time. Section 303(b) of the MSFCMA provides statutory authority to require permits for fisheries governed by management plans issued by the Secretary of Commerce.

Regulations at 50 CFR 635 require the permits outlined in the introductory paragraph. The importance of the information collected by permit issuance and the use of the permit system is explained in item #2.

2. Explain how, by whom, how frequently, and for what purpose the information will be used. If the information collected will be disseminated to the public or used to support information that will be disseminated to the public, then explain how the collection complies with all applicable Information Quality Guidelines.

Vessel Permits

The general information collected for vessel permits includes all or some of the following:

Vessel owner, corporate status, birthdate or corporation filed date, social security number or Federal ID number, names of additional owners, and contact information (e.g. address, phone, etc.);

Vessel name, registration, and port;

Vessel characteristics and construction type;

Gear type/category;

Signature and payment/delivery information.

Shark and swordfish limited access permit applications collect the following additional information:

Lease information (if applicable).

Transfer of tuna, shark and swordfish limited access permits require the following additional information:

Previous year's original valid/expired permit.

Shark, swordfish, and tuna limited access permits require submission of a signed hard-copy application in addition to the information indicated above. All other vessel permits can be obtained by submitting a hard-copy application, or using the automated permitting system (toll free telephone 1-888-USA-TUNA or website www.nmfspermits.com). The application necessary for each permit is identified below, and copies of applications are attached.

Collection of information through annual vessel permits provides current information on the vessel owners participating in these fisheries, thus facilitating quota monitoring necessary to avoid exceeding catch quotas for tunas, swordfish and sharks and landings caps for marlins. For example, NMFS requires that vessel permits be displayed to dealers and that permit numbers be recorded on dealer reports in order to validate landings of bluefin tuna.

A current permit holder list aids NMFS in the communication of fishery regulations and distribution of management program brochures, fish identification guides, and regulatory compliance guides. In addition, a permit "universe" facilitates collecting catch and effort information about recreational fisheries, as required by law. NMFS constructs sample frames for dockside and telephone surveys from permit holder lists and uses the list to select vessels for logbooks and/or at-seas observers (addressed under separate collections). Such surveys, logbooks and observer reports provide essential information for management of the Atlantic tunas and HMS fisheries in the United States, particularly in terms of allocation decisions which follow ICCAT and MSFCMA recommendations, such as allocating fishing opportunities consistent with traditional fishing patterns and considering the economic values to various user groups. NMFS operates a mandatory angler catch reporting program for bluefin tuna (addressed under a separate collection) that is linked to the permit number to avoid false reporting and facilitates enforcement. Another purpose of the vessel permit requirement is that it serves as a useful tool in support of enforcement of fishery regulations. That is, the permit can be revoked as a penalty for a violation of fishery conservation measures. Often, this is a more effective tool than a monetary fine.

Dealer Permits

The general information collected for dealer applications includes all or some of the following information:

Business & Owner Name and Contact information (e.g. phone, address, business website, etc.), birthdate, and social security number;

Facilities where product is received or other business addresses/contact information

Applicant Name and contact information

Federal Tax I.D. number

Type of dealer permit requested

Other NMFS dealers permit identification
Applicant Signature and date

In general, the purpose and use of dealer permits is to (1) identify fish dealers and the characteristics of their operations; (2) exercise influence over compliance (e.g. impose permit sanctions pending collection of required reports or unpaid penalties); (3) provide a mailing list for the dissemination of important information to the industry; and (4) provide a universe for data collection samples.

Although the information collected is not expected to be disseminated directly to the public, it may be used in the development or review of fishery management plans, and is therefore subject to NOAA's Information Quality Guidelines. As explained in the preceding paragraphs, the information gathered has utility. NOAA Fisheries will retain control over the information and safeguard it from improper access, modification, and destruction, consistent with NOAA standards for confidentiality, privacy, and electronic information. See Item #10 of this Supporting Statement for more information on confidentiality and privacy. The information collection is designed to yield data that meet all applicable information quality guidelines. Prior to dissemination, the information will be subjected to quality control measures and a pre-dissemination review pursuant to Section 515 of Public Law 106-554.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.

Both telephone and internet automation is available for Atlantic tunas, HMS Charter/headboat, and HMS recreational vessel permits. These automated systems are available on a 7-day/24 hour basis, and are available at no additional charge to the permit holder beyond the cost of the permit (See Items #12 and #13 for relative costs). After an electronic application has been submitted, vessel owner can track the application process and permit status via the internet. Once application processing is complete, a permit can be printed off the website or faxed or mailed back to the vessel owner. Alternatively, hard copy applications for these permits can be obtained directly from the internet site or through the mail via an automated internet or phone request, and can be filled out by hand and submitted by mail. Automated information is available on a toll free telephone line (888-USA-TUNA).

All other permit applications must be submitted in hard copy. Electronic versions of the applications are available to be printed and filled out by hand or as form-fillable .pdf files.

For Atlantic Tunas Dealer Permits, providing a pre-filled renewal application facilitates renewal. Vessel permits for Atlantic tunas, HMS Charter/headboat, and HMS Recreational also provide a simpler opportunity for renewal by providing pre-filled fields for both internet and phone renewal.

4. Describe efforts to identify duplication.

The HMS Advisory Panel meets at least once per year to discuss issues pertinent to management of HMS fisheries, including permits. This panel includes representatives from fishing and processing industries, environmentalists, and state representatives. Through this forum and the federal rule-making process, information including any potential duplication of permitting requirements is identified.

Vessel Permits

No other Federally issued fishing permits are required for the activities covered by the permits in this collection. State permits may be necessary for fishing in some states' waters for certain species. HMS permitted vessels may participate in other federally regulated commercial fisheries (i.e., NE multi-species) for which permits are issued. NMFS is investigating means to consolidate the permitting process so that permits for multiple fisheries may be issued/renewed through a single application process (i.e., one stop shopping).

Dealer Permit

U.S. dealers involved in international trade for BFT in the past have been required to obtain an Atlantic Tunas Dealer Permit or Pacific Tuna Dealers Permit (Control No. 0648-0202). The HMS ITP will now cover these activities; the Atlantic Tunas Dealer Permit will cover only domestic dealers, and the Pacific Tuna Dealers Permit will be discontinued. The HMS ITP will also cover dealers who internationally trade in bigeye tuna and swordfish, in order to implement ICCAT's newly recommended statistical document programs for bigeye tuna and swordfish. The HMS ITP will replace the need for a Swordfish Dealer Permit (Control No. 0648-0205) for swordfish import. The Swordfish Dealer Permit will be necessary only for certain types of domestic swordfish transactions.

5. If the collection of information involves small businesses or other small entities, describe the methods used to minimize burden.

Annual permitting does not have a significant impact on small businesses, organizations or government bodies. The minimal burden per application is outlined in Item #12. Impacts have been minimized for several vessel permits by providing application and renewal services over the internet and telephone, as discussed in Item # 2.

6. Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.

If this information collection were not conducted, the United States would have difficulty in complying with international obligations under ICCAT, possibly resulting in violations of

ICCAT catch recommendations. ICCAT penalties may include reduction in the assigned country catch quota equal to a minimum of 125% of the excess harvest. In addition, trade restrictions may be imposed on countries that fail to restrict catch to the level of the assigned quotas. This is particularly important for those species for which an international rebuilding program is in place such as bluefin tuna, swordfish, and blue and white marlins.

Estimates of the status of the Atlantic HMS resources would be less accurate without this information, since all contracting parties to ICCAT must submit catch and effort information on an annual basis. Without such catch and effort statistics, the conservation and management objectives of ICCAT with respect to the tuna and swordfish rebuilding programs could be jeopardized. Furthermore, it would be difficult for the United States to formulate domestic policy consistent with the MSFCMA, which must be based on sound socio-economic and biological data and analyses. NMFS would be less able to prepare documents such as the Regulatory Impact Review, Environmental Impact Statement, etc., as required under the Magnuson-Stevens Act, National Environmental Policy Act, and other applicable laws.

Annual permitting thus provides a more accurate vessel list and facilitates quota monitoring and data collections necessary to meet ICCAT obligations. Widening the timeframe for collection of information on HMS fisheries participants (e.g. every two years rather than annually) would provide a less accurate sampling frame that is the basis for fleet size calculations used for annual catch and effort estimates. Many vessels change hands or are moved from year to year. It is also necessary to permit dealers annually in order to ensure accurate records of landings and to communicate regulatory changes efficiently and effectively.

7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

Collection of information will be made in a manner consistent with OMB guidelines.

8. Provide a copy of the PRA Federal Register notice that solicited public comments on the information collection prior to this submission. Summarize the public comments received in response to that notice and describe the actions taken by the agency in response to those comments. Describe the efforts to consult with persons outside the agency to obtain their views on the availability of data, frequency of collection, the clarity of instructions and recordkeeping, disclosure, or reporting format (if any), and on the data elements to be recorded, disclosed, or reported.

No public responses regarding the reporting burden were received during the public comment period for this collection. The Federal Register notice requesting comment is attached (Attachment 9).

All of the permits covered under this collection were established via the federal rulemaking process, which required analyses of the impacts of the permits and provided an opportunity for public comment. In addition, a federal advisory committee (the HMS Advisory Panel) meets at least annually to provide input on HMS regulatory and operations programs.

The HMS Advisory Panel met most recently in March of 2005, and continues to support improved recreational monitoring as a high priority, which would not be possible without this collection.

9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

There are no payments or other remunerations to respondents.

10. Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.

The information collected is confidential under section 402(b) of the Magnuson-Stevens Act (16 U.S.C. 1801, et seq.). It is also confidential under NOAA Administrative Order 216-100, which sets forth procedures to protect confidentiality of fishery statistics.

The Privacy Act does apply to this collection-of-information because the social security number is requested on a voluntary basis. The social security number is needed to avoid inappropriate release of data: to distinguish between same names; to ensure that the records go to the same person through the use of this personal ID; when there are several operators on a vessel owned by a different individual, to ensure that the confidential data of each operator is protected; with misspellings and possible duplications, to provide a unique identifier to find records in the database; and to prevent release of confidential data to the wrong person.

11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private.

The additional questions are not of a sensitive nature. This collection of information requests the social security number (see item 10).

12. Provide an estimate in hours of the burden of the collection of information.

Burden hours, number of respondents, and opportunity costs for each permit are given in the table below.

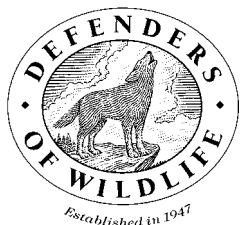

Re: Atlantic Highly Migratory Species Observer Notification Requirements

On behalf of Defenders of Wildlife and our 500,000 members and supporters, we would like to comment on the proposal to streamline the Atlantic Ocean's Highly Migratory Species' observer program published in the Federal Register on February 7th, 2005 (70 FR 24, 6418, Atlantic Highly Migratory Species Observer Notification Requirements). We believe any effort to reduce the data collected by observers or to reduce the frequency of reporting as a means of reducing paperwork would be highly detrimental to the effectiveness of the observer program and ocean conservation at large. While saving paper has its place, observer data from the Atlantic, Pacific, and elsewhere provides an enormously important tool for protecting the world's marine resources. Data from such programs improves our understanding of fisheries impacts on targeted stocks and ocean ecosystems, and contributes to the broader body of scientific knowledge about our world and the human impact upon it. In particular, vessel observer program for highly migratory species are often the primary means of collecting data on such species as sharks, tunas, and swordfish that are known to migrate across entire ocean basins. Vessel observer data plays a critical role in managing high seas fisheries. Rather than being weakened, observer programs should be bolstered to increase the information gained and the number of vessels covered.

Information Collected is Essential to the Proper Function of the Agency

According to the National Marine Fisheries Service, "NOAA Fisheries is dedicated to the stewardship of living marine resources through science-based conservation and management, and the promotion of healthy ecosystems."^a The information collected through the NMFS' observer program is essential to NMFS' goal of science-based conservation and management.

As NMFS' recognized in the Federal Register Notice, observers collect information on species caught, catch disposition, gear, effort, and bycatch. This information is invaluable in developing stock assessments for targeted species, bycatch estimates for non-targeted and protected species such as critically endangered sea turtles, and for improving overall management of the fisheries. Frequently, observers provide critical information that normal fishing logs

would not normally record, such as sightings of right whales that could be used to warn fishermen of highly trafficked right whale areas in order to prevent ship-strikes. Observer programs are often the only way scientists and policy-makers can get the data they need to make informed decisions on how to sustainably manage the Atlantic fisheries.

Overfishing

Resource managers face many challenges in determining the maximum sustainable yield for the species and stocks they manage. For marine species it is particularly difficult since scientists cannot just go out into the ocean and count every fish as is done with many terrestrial species. Observer data helps scientists determine both how many fish are being caught *and* how many fish are expected to still be swimming free, in order to determine the maximum sustainable yield and the level of current exploitation. It thus plays a fundamental role in assessing whether a particular stock is overfished.

At a time when the FAO estimates that 75% of fish stocks are fully exploited or overexploited and scientists estimate that large predatory fish have declined by 90% across vast regions of the oceans, such data is vitally needed to make informed and adequate conservation recommendations.

Managing stocks effectively requires very particular information not only the number of specimens caught, but also their size, their species, and sometimes their sex or manner of capture. While technology for monitoring fishing hauls is improving, it is far from a point where it can collect such data quickly and reliably. At the same time, fishermen may lack the time or training to collect comprehensive data, and may find it against their own interests to record data accurately and voluntarily. Until some new way of obtaining catch and interaction data is invented, observers remain the most reliable and unbiased sources of this crucial information. In addition, observer data allows fisheries and other marine scientists to extrapolate the size of the populations in question and determine the effect the fishing activities are having on the populations. The larger the data set, the closer the estimate will be to the actual status.

Overfishing is rampant throughout our world's oceans, but is especially apparent in the Atlantic. The decline of the Atlantic cod is well-known, and many other important species face a similar fate, including tuna, swordfish, and marlin. Already, stock assessments by NMFS and ICCAT are painting a grim picture. The West Atlantic Bluefin Tuna, East Atlantic Bluefin, North Atlantic Albacore Tuna, Atlantic Blue Marlin, Atlantic White Marlin, and West Atlantic Sailfish are all heavily overfished, with overfishing still ongoing.^b North Atlantic Swordfish is also overfished, but overfishing is not occurring. And South Atlantic Swordfish are "fully fished" and overfishing may be occurring. With these stocks in such perilous levels, close monitoring of catch and bycatch of juvenile fish is more important than ever.

Reducing Bycatch Should be the Priority, Not Reducing Administrative Burdens

Observer data is key to understanding and preventing the incidental bycatch of non-target species such as cetaceans, sharks, and critically endangered sea turtles and seabirds. Observer data informs scientists which species are caught, how many, the geographical location of high and low bycatch, and which fisheries are most associated with the bycatch of particular species. This data is crucial to protecting the ecosystem as a whole, rather than just the targeted species. For example, observer data on bycatch is critical to understanding the population dynamics of endangered albatrosses and leatherback sea turtles that are at great risk from fisheries interactions.

Sharks are especially vulnerable to over-exploitation because they are top-level predators that often have small natural populations and low reproductive rates. Adequate management and conservation of shark populations in the Atlantic is a problem that needs to be addressed through increased observer coverage, not less. More stringent bycatch measures need to be put in place for the conservation of sharks. Observers are needed to ensure that future management measures and those already in place, such as the ban on shark finning in the Atlantic, are strictly adhered to. Similarly, for those fisheries that specifically target sharks, observer data is necessary to adequately assess the status of shark populations in order to set appropriately protective quota levels.

In its 2003 Highly Migratory Species Bycatch Reduction Plan, NMFS identified increasing observer coverage in pelagic longline, bottom longline, and shark gillnet fisheries as a priority issue to be addressed in fiscal year 2005. We urge you to follow through on this and other measures to strengthen observer programs.

Administrative Burdens

Defenders does not believe that a two minute response time for vessel owners is overly onerous considering how important the information received is to the proper management of America's marine resources. NMFS requests comments on whether collecting information electronically provides a viable option for reducing paperwork while still gathering and keeping track of the same information that would have been collected through paper formats. We do not presently have the information necessary to assess this position. Recognizing the manifold ways in which the collection and management of electronic information can be compromised—whether through user error, machine failure or intentional interference—we urge you to undertake any such transition with extreme caution, to ensure that the potential for data loss is minimized.

Conclusion

The observer program provides information critical to the effective management of our oceans. As marine resources continue to decline due to overfishing and bycatch, accurate data to assess and combat the situation is essential. This is especially true for highly migratory species such as tunas, swordfish, sharks, sea birds, sea turtles, and other marine wildlife that are especially vulnerable to heavy exploitation. While efforts to streamline observer programs to improve the collection and dissemination of data are welcome, NMFS should not compromise the integrity of those programs for the sake of modest savings in time or money. Observer data taken today

provides a stronghold for conserving our oceans in the future. As the momentum from the US Commission on Oceans Policy and Pew Ocean Commission reports drives us forward, we urge you to make conservation the priority instead of taking steps backwards in the name of reducing administrative “burdens.”

If your application/renewal, including payment, is complete, your permit will be mailed, faxed, or available to print (depending on your preferred delivery method) within 3 business days. GULF COASTAL MIGRATORY PELAGIC CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish or possess a coastal migratory pelagic fish in or from Federal waters in the Gulf of Mexico, a charter permit must be issued to the vessel and be on board. **Permits for Gulf coastal migratory pelagic charter are under a moratorium.** No new vessel may be permitted except by transfer of a valid (not expired) permit. To transfer a permit, the original valid (not expired) permit must be returned with an application and applicable documents. **Permits must be renewed within one year of the expiration date.**

GULF REEF FISH CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish for or possess a reef fish in or from Federal waters of the Gulf of Mexico, a moratorium charter permit must be issued to the vessel and be on board. **Permits for Gulf of Mexico reef fish charter are under a moratorium.** No new vessel may be permitted except by transfer of a valid (not expired) permit. To transfer a permit, the original valid (not expired) permit must be returned with an application and applicable documents. **Permits must be renewed within one year of the expiration date.**

SOUTH ATLANTIC COASTAL MIGRATORY PELAGIC CHARTER OR SNAPPER-GROUPER CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish for or possess a coastal migratory pelagic or snapper-grouper in or from Federal waters off the southern Atlantic states, a charter permit must be issued to the vessel and be on board.

ATLANTIC DOLPHIN-WAHOO CHARTER VESSEL/HEADBOAT - For a person aboard a vessel that is operating as a charter vessel/headboat to fish for or possess a dolphin-wahoo in or from Federal waters in the Atlantic, an Atlantic dolphin-wahoo charter vessel/headboat permit must be issued to that vessel. There are no earned income or landing requirements for this permit. An owner of a charter vessel/headboat who desires to sell dolphin is required to obtain a dolphin-wahoo commercial vessel permit (see below) in addition to the charter vessel/headboat permit. (The sale of wahoo harvested in the Atlantic EEZ by a vessel operating as a charter vessel/headboat is not allowed.)

ATLANTIC DOLPHIN-WAHOO COMMERCIAL VESSEL - A vessel must be issued an Atlantic dolphin-wahoo commercial permit to be eligible for exemption from the bag and possession limits for dolphin-wahoo in the Atlantic EEZ or to sell dolphin-wahoo harvested in the Atlantic EEZ. If the vessel has a Federal commercial permit issued by the Southeast Region, dolphin-wahoo will be added to the fisheries for which the permit is valid upon written request (do not use this application). There are no earned income or landing requirements for this permit.

SPANISH MACKEREL - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits and to fish under a commercial allocation for Spanish mackerel, a commercial permit must be issued to the vessel and be on board. At time of application income criteria must be submitted. *If applying for a spanish mackerel permit, earned income or gross sales from one of three years prior to application must be submitted at time of application. See Earned Income or Gross Sales Requirements for Commercial Permits.*

SPINY LOBSTER - For a vessel fishing in Federal waters off states other than Florida to be exempt from the daily catch and possession limit, a commercial spiny lobster permit must be issued to the vessel and be on board. Florida's requirements apply to a vessel fishing in Federal waters off Florida. To possess a separated spiny lobster tail in or from Federal waters, a tail-separation permit must be issued to the vessel and be on board. *If applying for a commercial spiny lobster permit income from the previous calendar year must be submitted at time of application.*

KING MACKEREL - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits and to fish under a commercial allocation for king mackerel, a commercial permit must be issued to the vessel and be on board. Permits for king mackerel are under a moratorium. No new vessel may be permitted except by transfer of a valid (not expired) permit. To transfer a permit, the original valid (not expired) permit must be returned with the application and applicable documents. **Permits must be renewed within one year of the expiration date.**

GILLNET ENDORSEMENT FOR KING MACKEREL - For a person aboard a vessel in Federal waters to use a run-around gillnet for king mackerel in the southern Florida west coast subzone, a commercial permit for king mackerel with a gillnet endorsement must be issued to the vessel and be on board. Permits for gillnet endorsement for king mackerel are under a moratorium. No new vessel may be permitted except by transfer of a valid (not expired) permit. To transfer a permit, the original valid (not expired) permit must be returned with the application and applicable documents.

GULF OF MEXICO REEF FISH - As a prerequisite to sell reef fish in or from Federal waters and to be eligible for exemption from the bag limits, a commercial permit must be issued to the vessel and be on board. Permits for the reef fish fishery are under a moratorium. No new vessels may be permitted except by transfer of a valid (not expired) permit. To transfer a permit, the original valid (not expired) permit must be returned with the application and applicable documents. **Permits must be renewed within one year of the expiration date.**

SOUTH ATLANTIC LIMITED ACCESS ROCK SHRIMP ENDORSEMENT - For a person aboard a fishing vessel to fish for rock shrimp in Federal waters from the Virginia/North Carolina border to the East Coast of Florida, or possess rock shrimp in or from Federal waters, a vessel permit for rock shrimp must be issued to the vessel and be on board. However, to participate in that fishery off Georgia and the east coast of Florida, a limited-access endorsement for South Atlantic rock shrimp is required.

SOUTH ATLANTIC SNAPPER-GROUPER EXCLUDING WRECKFISH - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits, to engage in a directed fishery for tilefish or to use a sea bass pot, a commercial permit must be issued to the vessel and be on board. Permits for the South Atlantic snapper-grouper fishery are under a moratorium. No new vessels may be permitted except by transfer of a valid (not expired) permits. A person desiring to acquire a limited access transferable permit for South Atlantic snapper-grouper must obtain and exchange two such permits for one new permit. The original valid (not expired) permits must be returned with the application and applicable documents. **Permits must be renewed within 60 days of the expiration date.**

SHARK - As a prerequisite to sell a shark in or from Federal waters and to be eligible for exemption from the bag limits, a commercial permit must be issued to the vessel and be on board. Permits for the shark fishery are under a moratorium. No new vessels may be permitted except by transfer of a valid (not expired) limited entry permit. To transfer a permit, the original valid (not expired) permit must be returned with the application and applicable documents. **Permits must be renewed within one year of the expiration date.**

SWORDFISH - To fish for or possess swordfish in or from the North Atlantic Ocean, or take swordfish as bycatch, whether or not retained, a commercial permit must be issued to the vessel and be on board. Permits for the swordfish fishery are under a moratorium. No new vessels may be permitted except by transfer of a valid (not expired) limited entry permit. To transfer a permit, the original valid (not expired) permit must be returned with the application and applicable documents. **Permits must be renewed within one year of the expiration date.**

If you would like your permit and associated documents returned to you via overnight mail, enclose a **FEDERAL EXPRESS** air bill, complete with your delivery address (no PO Box numbers), telephone number, and your FEDEX account number or credit card number with expiration date.
4. If transferring a Gulf charter/headboat permit, a copy of the U.S. Coast Guard Operator of Uninspected Passenger Vessel license (commonly referred to as a 6-pack license) or a U.S. Coast Guard Masters license must be provided, along with any other requested information. A U.S. Coast Guard Certificate of Inspection must be provided if passenger capacity is greater than 6 passengers.
5. Each vessel issued a South Atlantic rock shrimp permit (regardless of whether or not issued the limited access endorsement), when at sea or offloading, is required to have on board at least one person who has a Federal operator permit card issued by the Southeast Regional Office.

If vessel owner already holds other permits, a written request, original endorsement and check/money order must be submitted for transfer.
- **Transfer of Rock Shrimp Endorsement - Same Owner** - If transferring rights to same owner different vessel and vessel already holds permits, you must submit a written request, original permit, and check/money order. If vessel holds no permits, an application, you must submit a copy of the U.S. Coast Guard documentation (or state registration, if not documented), original endorsement, and check/money order.

4. If applying for a TRANSFER of a SOUTH ATLANTIC SNAPPER-GROUPER PERMIT, please provide the following information:

- **Transfer of Unlimited Permit - Same Owner:** An owner of a permitted vessel may transfer the vessel permit to another vessel owned by the same owner by returning the original permit with an application for a vessel permit for the replacement vessel.
- **Transfer of Unlimited Permit - New Owner:** A person desiring to acquire a limited access transferable permit for South Atlantic snapper-grouper permit must obtain and exchange two such permits for one new permit. Notwithstanding any other provision of the law, no person is required to respond to, nor shall any person be subject to, a penalty for failure to comply with a collection of information subject to the requirements of the Paperwork Reduction Act, unless that collection of information displays a currently valid OMB Control Number.

16 USC CHAPTER 16A - ATLANTIC TUNAS CONVENTION

Sec. 971d. Administration

- (a) Regulations; cooperation with other parties to Convention; utilization of personnel, services, and facilities for enforcement

The Secretary is authorized and directed to administer and enforce all of the provisions of the Convention, this chapter, and regulations issued pursuant thereto, except to the extent otherwise provided for in this chapter. **In carrying out such functions the Secretary is authorized and directed to adopt such regulations as may be necessary** to carry out the purposes and objectives of the Convention and this chapter, and with the concurrence of the Secretary of State, he may cooperate with the duly authorized officials of the government of any party to the Convention. In addition, the Secretary may utilize, with the concurrence of the Secretary of the department in which the Coast Guard is operating insofar as such utilization involves enforcement at sea, with or without reimbursement and by agreement with any other Federal department or agency, or with any agency of any State, the personnel, services, and facilities of that agency for enforcement purposes with respect to any vessel in the exclusive economic zone, or wherever found, with respect to any vessel documented under the laws of the United States, and any vessel numbered or otherwise licensed under the laws of any State. When so utilized, such personnel of the States of the United States are authorized to function as Federal law enforcement agents for these purposes, but they shall not be held and considered as employees of the United States for the purposes of any laws administered by the Director of the Office of Personnel Management.

Tuna Conservation Act of 1950

TITLE 16--CONSERVATION

CHAPTER 16--TUNA CONVENTIONS

Sec. 955. Secretary of State to act for United States

(a) Approval of commission bylaws and rules; action on reports, requests, and recommendations

The Secretary of State is authorized to approve or disapprove, on behalf of the United States Government, bylaws and rules, or amendments thereof, adopted by each commission and submitted for approval of the United States Government in accordance with the provisions of the conventions, and, with the concurrence of the Secretary of Commerce, to approve or disapprove the general annual programs of the commissions. The Secretary of State is further authorized to receive, on behalf of the United States Government, reports, requests, recommendations, and other communications of the commissions, and to take appropriate action thereon either directly or by reference to the appropriate authority.

(b) Regulations

Regulations recommended by each commission pursuant to the convention requiring the submission to the commission of records of operations by boat captains or other persons who participate in the fisheries covered by the convention, upon the concurrent approval of the Secretary of State and the Secretary of Commerce, shall be promulgated by the latter and upon publication in the Federal Register, shall be applicable to all vessels and persons subject to the jurisdiction of the United States.

(c) Rulemaking procedures; prohibitions

Regulations required to carry out recommendations of the commission made pursuant to paragraph 5 of article II of the Convention for the Establishment of an Inter-American Tropical Tuna Commission shall be promulgated as hereinafter provided by the Secretary of Commerce upon approval of such recommendations by the Secretary of State and the Secretary of Commerce. The Secretary of Commerce shall cause to be published in the Federal Register a general notice of proposed rulemaking and shall afford interested persons an opportunity to participate in the rulemaking through (1) submission of written data, views, or arguments, and (2) oral presentation at a public hearing. Such regulations shall be published in the Federal Register and shall be accompanied by a statement of the considerations involved in the issuance of the regulations. After publication in the Federal Register such regulations shall be applicable to all vessels and persons subject to the jurisdiction of the United States on such date as the Secretary of Commerce shall prescribe, but in no event prior to an agreed date for the application by all countries whose vessels engage in fishing for species covered by the convention in the regulatory area on a meaningful scale, in terms of effect upon the success of the conservation program, of effective measures for the implementation of the commission's recommendations applicable to all vessels and persons subject to their respective jurisdictions. The Secretary of Commerce shall suspend at any time the application of any such regulations when, after consultation with the Secretary of State and the United States Commissioners, he determines that foreign fishing operations in the regulatory area are such as to constitute a serious threat to the achievement of the objectives of the commission's recommendations. The regulations thus promulgated may include the selection for regulation of one or more of the species covered by the convention; the division of the convention waters into areas; the establishment of one or more open or closed seasons as to each area; the limitation of the size of the fish and quantity of the catch which may be taken from each area within any

season during which fishing is allowed; the limitation or prohibition of the incidental catch of a regulated species which may be retained, taken, possessed, or landed by vessels or persons fishing for other species of fish; the requiring of such clearance certificates for vessels as may be necessary to carry out the purposes of the convention and this chapter; and such other measures incidental thereto as the Secretary of Commerce may deem necessary to implement the recommendations of the commission: Provided, That upon the promulgation of any such regulations the Secretary of Commerce shall promulgate additional regulations, with the concurrence of the Secretary of State, which shall become effective simultaneously with the application of the regulations hereinbefore referred to (1) to prohibit the entry into the United States, from any country when the vessels of such country are being used in the conduct of fishing operations in the regulatory area in such manner or in such circumstances as would tend to diminish the effectiveness of the conservation recommendations of the commission, of fish in any form of those species which are subject to regulation pursuant to a recommendation of the commission and which were taken from the regulatory area; and (2) to prohibit entry into the United States, from any country, of fish in any form of those species which are subject to regulation pursuant to a recommendation of the commission and which were taken from the regulatory area by vessels other than those of such country in such manner or in such circumstances as would tend to diminish the effectiveness of the conservation recommendations of the commission. In the case of repeated and flagrant fishing operations in the regulatory area by the vessels of any country which seriously threaten the achievement of the objectives of the commission's recommendations, the Secretary of Commerce, with the concurrence of the Secretary of State, may, in his discretion, also prohibit the entry from such country of such other species of tuna, in any form, as may be under investigation by the commission and which were taken in the regulatory area. The aforesaid prohibitions shall continue until the Secretary of Commerce is satisfied that the condition warranting the prohibition no longer exists, except that all fish in any form of the species under regulation which were previously prohibited from entry shall continue to be prohibited from entry.

Sec. 953. General Advisory Committee and Scientific Advisory Subcommittee

(a) Appointments; public participation; compensation

The Secretary, in consultation with the United States Commissioners, shall--

(1) appoint a General Advisory Committee which shall be composed of not less than 5 nor more than 15 persons with balanced representation from the various groups participating in the fisheries included under the conventions, and from nongovernmental conservation organizations;

(2) appoint a Scientific Advisory Subcommittee which shall be composed of not less than 5 nor more than 15 qualified scientists with balanced representation from the public and private sectors, including nongovernmental conservation organizations;

(3) establish procedures to provide for appropriate public participation and public meetings and to provide for the confidentiality of confidential business data; and

(4) fix the terms of office of the members of the General Advisory Committee and Scientific Advisory Subcommittee, who shall receive no compensation for their services as such members.

(b) Functions

(1) General Advisory Committee

The General Advisory Committee shall be invited to have

representatives attend all nonexecutive meetings of the United States sections and shall be given full opportunity to examine and to be heard on all proposed programs of investigations, reports, recommendations, and regulations of the Commission. The General Advisory Committee may attend all meetings of the international commissions to which they are invited by such commissions.

(2) Scientific Advisory Subcommittee

(A) Advice

The Scientific Advisory Subcommittee shall advise the General Advisory Committee and the Commissioners on matters including--

- (i) the conservation of ecosystems;
- (ii) the sustainable uses of living marine resources related to the tuna fishery in the eastern Pacific Ocean; and
- (iii) the long-term conservation and management of stocks of living marine resources in the eastern tropical Pacific Ocean.

(B) Other functions and assistance

The Scientific Advisory Subcommittee shall, as requested by the General Advisory Committee, the United States Commissioners, or the Secretary, perform functions and provide assistance required by formal agreements entered into by the United States for this fishery, including the International Dolphin Conservation Program. These functions may include--

- (i) the review of data from the Program, including data received from the Inter-American Tropical Tuna Commission;
- (ii) recommendations on research needs, including ecosystems, fishing practices, and gear technology research, including the development and use of selective, environmentally safe and cost-effective fishing gear, and on the coordination and facilitation of such research;
- (iii) recommendations concerning scientific reviews and assessments required under the Program and engaging, as appropriate, in such reviews and assessments;
- (iv) consulting with other experts as needed; and
- (v) recommending measures to assure the regular and timely full exchange of data among the parties to the Program and each nation's National Scientific Advisory Committee (or its equivalent).

(3) Attendance at meetings

The Scientific Advisory Subcommittee shall be invited to have representatives attend all nonexecutive meetings of the United States sections and the General Advisory Subcommittee and shall be given full opportunity to examine and to be heard on all proposed programs of scientific investigation, scientific reports, and scientific recommendations of the commission. Representatives of the Scientific Advisory Subcommittee may attend meetings of the Inter-American Tropical Tuna Commission in accordance with the rules of such Commission.

Magnuson-Stevens Fishery Conservation and Management Act

Public Law 94-265

SEC. 303. CONTENTS OF FISHERY MANAGEMENT PLANS 16 U.S.C. 1853

95-354, 99-659, 101-627, 104-297

(a) REQUIRED PROVISIONS.--Any fishery management plan which is prepared by any Council, or by the Secretary, with respect to any fishery, shall--

(1) contain the conservation and management measures, applicable to foreign fishing and fishing by vessels of the United States, which are--

(A) necessary and appropriate for the conservation and management of the fishery to prevent overfishing and rebuild overfished stocks, and to protect, restore, and promote the long-term health and stability of the fishery;

(B) described in this subsection or subsection (b), or both; and

(C) consistent with the national standards, the other provisions of this Act, regulations implementing recommendations by international organizations in which the United States participates (including but not limited to closed areas, quotas, and size limits), and any other applicable law;

(2) contain a description of the fishery, including, but not limited to, the number of vessels involved, the type and quantity of fishing gear used, the species of fish involved and their location, the cost likely to be incurred in management, actual and potential revenues from the fishery, any recreational interest in the fishery, and the nature and extent of foreign fishing and Indian treaty fishing rights, if any;

(3) assess and specify the present and probable future condition of, and the maximum sustainable yield and optimum yield from, the fishery, and include a summary of the information utilized in making such specification;

(4) assess and specify--

(A) the capacity and the extent to which fishing vessels of the United States, on an annual basis, will harvest the optimum yield specified under paragraph (3),

(B) the portion of such optimum yield which, on an annual basis, will not be harvested by fishing vessels of the United States and can be made available for foreign fishing, and

(C) the capacity and extent to which United States fish processors, on an annual basis, will process that portion of such optimum yield that will be harvested by fishing vessels of the United States;

(5) specify the pertinent data which shall be submitted to the Secretary with respect to commercial, recreational, and charter fishing in the fishery, including, but not limited to, information regarding the type and quantity of fishing gear used, catch by species in numbers of fish or weight thereof, areas in which fishing was engaged in, time of fishing, number of hauls, and the estimated processing capacity of, and the actual processing capacity utilized by, United States fish processors;

(6) consider and provide for temporary adjustments, after consultation with the Coast Guard and persons utilizing the fishery, regarding access to the fishery for vessels otherwise prevented from harvesting because of weather or other ocean conditions affecting the safe conduct of the fishery; except that the adjustment shall not adversely affect conservation efforts in other fisheries or discriminate among participants in the affected fishery;

(7) describe and identify essential fish habitat for the fishery based on the guidelines established by the Secretary under section 305(b)(1)(A), minimize to the extent practicable adverse effects on such habitat caused by fishing, and identify other actions to encourage the conservation and enhancement of such habitat;

(8) in the case of a fishery management plan that, after January 1, 1991, is submitted to the Secretary for review under section 304(a) (including any plan for which an amendment is submitted to the Secretary for such review) or is prepared by the Secretary, assess and specify the nature and extent of scientific data which is needed for effective implementation of the plan;

(9) include a fishery impact statement for the plan or amendment (in the case of a plan or amendment thereto submitted to or prepared by the Secretary after October 1, 1990) which shall assess, specify, and describe the likely effects, if any, of the conservation and management measures on--

(A) participants in the fisheries and fishing communities affected by the plan or amendment; and

(B) participants in the fisheries conducted in adjacent areas under the authority of another Council, after consultation with such Council and representatives of those participants;

(10) specify objective and measurable criteria for identifying when the fishery to which the plan applies is overfished (with an analysis of how the criteria were determined and the relationship of the criteria to the reproductive potential of stocks of fish in that fishery) and, in the case of a fishery which the Council or the Secretary has determined is approaching an overfished condition or is overfished, contain conservation and management measures to prevent overfishing or end overfishing and rebuild the fishery;

(11) establish a standardized reporting methodology to assess the amount and type of

bycatch occurring in the fishery, and include conservation and management measures that, to the extent practicable and in the following priority--

(A) minimize bycatch; and

(B) minimize the mortality of bycatch which cannot be avoided;

(12) assess the type and amount of fish caught and released alive during recreational fishing under catch and release fishery management programs and the mortality of such fish, and include conservation and management measures that, to the extent practicable, minimize mortality and ensure the extended survival of such fish;

(13) include a description of the commercial, recreational, and charter fishing sectors which participate in the fishery and, to the extent practicable, quantify trends in landings of the managed fishery resource by the commercial, recreational, and charter fishing sectors; and

(14) to the extent that rebuilding plans or other conservation and management measures which reduce the overall harvest in a fishery are necessary, allocate any harvest restrictions or recovery benefits fairly and equitably among the commercial, recreational, and charter fishing sectors in the fishery.

(b) DISCRETIONARY PROVISIONS.--Any fishery management plan which is prepared by any Council, or by the Secretary, with respect to any fishery, may--

(1) require a permit to be obtained from, and fees to be paid to, the Secretary, with respect to--

(A) any fishing vessel of the United States fishing, or wishing to fish, in the exclusive economic zone [or special areas,]* or for anadromous species or Continental Shelf fishery resources beyond such zone [or areas]*;

(B) the operator of any such vessel; or

(C) any United States fish processor who first receives fish that are subject to the plan;

(2) designate zones where, and periods when, fishing shall be limited, or shall not be permitted, or shall be permitted only by specified types of fishing vessels or with specified types and quantities of fishing gear;

(3) establish specified limitations which are necessary and appropriate for the conservation and management of the fishery on the--

(A) catch of fish (based on area, species, size, number, weight, sex, bycatch, total biomass, or other factors);

(B) sale of fish caught during commercial, recreational, or charter fishing, consistent with any applicable Federal and State safety and quality requirements; and

(C) transshipment or transportation of fish or fish products under permits issued pursuant to section 204;

(4) prohibit, limit, condition, or require the use of specified types and quantities of fishing gear, fishing vessels, or equipment for such vessels, including devices which may be required to facilitate enforcement of the provisions of this Act;

(5) incorporate (consistent with the national standards, the other provisions of this Act, and any other applicable law) the relevant fishery conservation and management measures of the coastal States nearest to the fishery;

(6) establish a limited access system for the fishery in order to achieve optimum yield if, in developing such system, the Council and the Secretary take into account--

(A) present participation in the fishery,

(B) historical fishing practices in, and dependence on, the fishery,

(C) the economics of the fishery,

(D) the capability of fishing vessels used in the fishery to engage in other fisheries,

(E) the cultural and social framework relevant to the fishery and any affected fishing communities, and

(F) any other relevant considerations;

(7) require fish processors who first receive fish that are subject to the plan to submit data (other than economic data) which are necessary for the conservation and management of the fishery;

(8) require that one or more observers be carried on board a vessel of the United States engaged in fishing for species that are subject to the plan, for the purpose of collecting data necessary for the conservation and management of the fishery; except that such a vessel shall not be required to carry an observer on board if the facilities of the vessel for the quartering of an observer, or for carrying out observer functions, are so inadequate or unsafe that the health or safety of the observer or the safe operation of the vessel would be jeopardized;

(9) assess and specify the effect which the conservation and management measures of the plan will have on the stocks of naturally spawning anadromous fish in the region;

(10) include, consistent with the other provisions of this Act, conservation and management measures that provide harvest incentives for participants within each gear group to employ fishing practices that result in lower levels of bycatch or in lower levels of the mortality of bycatch;

(11) reserve a portion of the allowable biological catch of the fishery for use in scientific research; and

(12) prescribe such other measures, requirements, or conditions and restrictions as are determined to be necessary and appropriate for the conservation and management of the fishery.

(c) PROPOSED REGULATIONS.--Proposed regulations which the Council deems necessary or appropriate for the purposes of--

(1) implementing a fishery management plan or plan amendment shall be submitted to the Secretary simultaneously with the plan or amendment under section 304; and

(2) making modifications to regulations implementing a fishery management plan or plan amendment may be submitted to the Secretary at any time after the plan or amendment is approved under section 304.

Timely written notification of the return/destruction of APO materials or conversion to judicial protective order is hereby requested. Failure to comply with the regulations and terms of an APO is a violation which is subject to sanction.

I. Abstract

Under the provisions of the Magnuson-Stevens Fishery Conservation and Management Act (16 U.S.C. 1801 *et seq.*), the National Oceanic and Atmospheric Administration's National Marine Fisheries Service (NMFS) is responsible for management of the Nation's marine fisheries. In addition, NMFS must comply with the United States' obligations under the Atlantic Tunas Convention Act of 1975 (16 U.S.C. 971 *et seq.*). NMFS permits fishing vessels and dealers in order to collect the information necessary to comply with domestic and international obligations, secure compliance with regulations, and disseminate necessary information.

Current regulations at 50 CFR part 635.4 require that vessels participating in commercial and recreational fisheries for highly migratory species (HMS), dealers purchasing Atlantic HMS from a vessel, and dealers importing or exporting bluefin tuna or importing swordfish obtain a permit from NMFS. A final rule which will go into effect on July 1, 2005, (69 FR 67268, November 17, 2004) will also require the HMS International Trade Permit (ITP) for international trade of frozen bigeye tuna, southern bluefin tuna, and export of swordfish.

This action addresses the renewal of permit applications currently approved under 0648-0327, including vessel permits for Atlantic tunas, HMS charter/headboats, and HMS angling, and the HMS ITP. In addition, vessel permits for swordfish (directed, incidental, and hand gear) and sharks (directed and incidental) currently approved under collection 0648-0205 will be merged into this collection and renewed; dealer permits for sharks and swordfish currently approved under collection 0648-0205 will be merged into this

collection and renewed; and dealer permits for Atlantic tunas, currently approved under collection 0648-0202 will be merged into this collection and renewed.

I. Abstract

The National Marine Fisheries Service (NMFS) Alaska Region manages the U.S. groundfish fisheries of the Exclusive Economic Zone (EEZ) off Alaska under the Fishery Management Plan for Groundfish of the Gulf of Alaska and the Fishery Management Plan for the Groundfish Fishery of the Bering Sea and Aleutian Islands Management Area (FMPs). The North Pacific Fishery Management Council prepared the FMPs pursuant to the Magnuson-Stevens Fishery Conservation and Management Act. The regulations implementing the FMPs are at 50 CFR part 679.

The recordkeeping and reporting requirements at 50 CFR part 679 form
