## 10. Abstract

Participants in the Gulf of Mexico stone crab fishery in the exclusive economic zone off Florida are required to obtain Federal fishing permits under a new trap limitation program. That program complements the stone crab trap limitation program implemented by Florida in that state's waters. As part of the Federal process, persons found ineligible may appeal NOAA's ineligibility determination through an appeals process. NOAA needs information from the applications for the identification of fishing vessels by area and the management of the fisheries.

## SUPPORTING STATEMENT

## SOUTHEAST REGION STONE CRAB VESSEL PERMIT ISSUANCE UNDER NEW TRAP LIMITATION PROGRAM

This submission is intended to eventually be part of the Permits Family of Forms but is being submitted separately because another 0648-0205 submission is currently at OMB. It is our intent to merge these requirements into 0648-0205 as soon as possible.

## A. JUSTIFICATION

## 1. Explain the circumstances that make the collection of information necessary.

The legislative authority to collect data from the various sectors of the economy that harvest marine resources in the exclusive economic zone (EEZ) is the Magnuson-Stevens Fishery Conservation and Management Act (Magnuson-Stevens Act). Under this authority the Secretary of Commerce has promulgated separate rules that require specific types of data submissions for the application process to obtain fishing permits and endorsements as well as notification of certain activities.

The National Marine Fisheries Service (NMFS) is issuing a proposed rule to implement Amendment 7 to the Fishery Management Plan for the Stone Crab Fishery of the Gulf of Mexico. The Florida Fish and Wildlife Conservation Commission (FFWCC) adopted rules for management of the fishery in state waters. The FFWCC program will stabilize the fishery at optimum sustainable yield by decreasing the number of traps from about 1.3 million to 0.6 million within a projected 30 -year period. However, the FFWCC voted to postpone implementation of its program until October 2002 (the beginning of the 2002/2003 season). FFWCC officials determined that the state program delay was necessary when they realized that they could not deliver tags to fishermen during June/July 2001, when fishermen would be repairing and preparing their traps for the 2001/2002 season. The commercial industry also supports this delay.

The FFWCC has requested (through the Gulf of Mexico Fishery Management Council) that NMFS provide a similar delay for implementation of the proposed Federal program.
Accordingly, the proposed rule proposes an implementation date for the Federal program that would coincide with the implementation of the FFWCC program. Approval and implementation of the Federal program at this time are imperative to allow sufficient time to process applications and potential appeals, and deliver Federal trap tags to approved fishermen in time so as to track the timing of the FFWCC program. The FFWCC appeals process already is underway.

Effective October 1, 2002, for a person aboard a vessel, except a person who is in compliance with the FFWCC stone crab trap limitation program, to possess or use a stone crab trap, possess more than 1 gallon of stone crab claws, or sell stone crab claws in or from the management area, a valid Federal commercial vessel permit for stone crab must have been issued to the vessel and
must be on board. The Federal program is for the commercial stone crab fishery in the EEZ off Florida's west coast, including the area off Monroe County, FL (i.e., the management area) that would complement the stone crab trap limitation program implemented by the FFWCC in state waters. Issuance of permits under the Federal program would be limited to applicants who could not qualify for, or chose not to qualify for FFWCC's license, trap certificates, and trap tags. Under the Federal program, an applicant who could meet the Federal eligibility requirements (based on landings during the 1995-1998 time period described in the proposed rule) and who does not possess the FFWC's license and trap certificates would be issued a Federal vessel permit (trap certificate), and trap tags. NMFS would obtain data on stone crab landed in Florida directly from that state (rather than from the applicants or dealers). Landings of stone crab harvested from the management unit or Florida's state waters but landed in a state other than Florida may be documented by dealer records that the fishermen obtain and submit to NMFS. The Federal permit and tags are valid in the EEZ only.

The trap certificate under the Federal program (unlike the state program) is non-transferable. Therefore, unlike the state certificate, the Federal trap certificate would not need to be a separate form but would instead be issued as a permit.

Concerning the collection of data on stone crab, the implementing regulations contain five collection-of-information requirements subject to the Paperwork Reduction Act, specifically information on landings of stone crab, completion of a stone crab commercial vessel permit application (Multiple Fishery Vessel Application (Application)), submissions of appeals of NMFS' initial denial of a commercial vessel permit, vessel identification, and gear identification.

This document requests approval to collect information regarding landings of stone crab, completion of the Application, and submissions of appeals of NMFS' initial denial of a commercial vessel permit, as required for the Federal permit issuance process under Amendment 7. An appeal must include copies of landing records relating to eligibility, such other reliable evidence upon which the facts related to issuance can be resolved, and a concise statement of the reasons the initial denial should be reversed or modified. These three collections are part of the process needed to properly implement the stone crab permit limitation system that complements Florida's similar program. The vessel and gear identification requirements have been approved by OMB under control numbers 0648-0358 and 0648-0359, respectively, with response times of 45 minutes and 7 minutes, respectively.

An applicant for a Federal stone crab vessel permit would be required to obtain an Application form from (and submit it to) NMFS. The form will be provided through a modification of the Application by adding a "stone crab" entry in Section 8 of that form. Information on the Application to be provided by stone crab vessel permit applicants would include the vessel's name, hull identification number, and state registration or Coast Guard documentation number; landings data for use by NMFS in determining eligibility; the desired color code for use in identifying the vessel and buoys; name, address, county, telephone number, and other identifying information of the vessel owner and of the applicant, if other than the owner; any other information concerning the vessel, gear characteristics, hull type, gross tonnage, net tonnage,
principal fisheries engaged in, or fishing areas, as specified on the Application. In addition, a copy of the vessel's valid U.S. Coast Guard certificate of documentation or, if not documented, a copy of its valid state registration certificate would be required with each application. Amendment 7 includes no requirement that the permitted owner or operator have earned income from fishing.

## 2. Explain how, by whom, how frequently, and for what purpose the information will be used.

NMFS will use the vessel/ownership and related information collected on the Application to help identify and manage all of the permit types handled by that form. Stone crab is a new permit type to be added to the Application; these data also need to be collected for the stone crab fishery for the same purpose.
a) Information such as name and address of owner and operator is used to identify the respondent and the legal entity controlling the fishing practices of the vessel. This latter requirement is essential in identifying participants and monitoring the compliance of the various requirements.
b) The documentation or state registration number, hull registration number, county, hull type, gross tonnage, net tonnage, and name of the vessel are essential for identifying participation.
c) Vessel characteristics (including gross and net tonnage for certain swordfish/shark permits), gear specification, fishing areas, and other information is necessary to ensure the correct permit issuance is competed by NMFS per the existing regulations.
d) The collection of vessel-specific information regarding landings of stone crab will be used by NMFS to calculate eligibility and the maximum allowable number of traps. NMFS would obtain data on stone crab landed in Florida directly from that state (rather than from the applicants or dealers). Landings of stone crab harvested from the management unit or Florida's state waters, but landed in a state other than Florida, may be documented by dealer records that the fishermen obtain and submit to NMFS.
e) The proposed submissions of appeals of NMFS' initial denial of a commercial vessel permit, is required to properly administer the Federal permit program and determination of eligible participants. Submittal of the appeal documents, including landings information, is needed to complete the appeals process and thereby provide appropriate Federal management of the fishery.
3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological techniques or other forms of information technology.

The Southeast Region's Web site allows the public to obtain a printed copy of the permit application via downloading to their printer. Otherwise, the Southeast Region currently has no resource or technological capability for electronic (i.e., Web site) permit application and issuance. This capability cannot be accomplished in the Southeast Region without significant changes to the permit issuance criteria and our permit issuance processes. These changes have been initiated, in that the Southeast Region Permits Team is switching from a non-Web database (Rbase) to a Web-based database (Oracle) in the future. The Southeast Region also may initiate clearance of a survey of permitted vessel owners to determine the feasibility of Web site application and associated costs/benefits. The survey results will be used to evaluate the feasibility of electronic permit transactions for possible inclusion in future permitting system changes and resource/technology allocations. Such changes could support NOAA's proposed initiative for One-Stop Shopping (to improve customer service through coordination of NOAA consultation and permitting activities).

## 4. Describe efforts to identify duplication.

The Magnuson-Stevens Act's operational guidelines require each Fishery Management Plan (FMP) to evaluate existing state and federal laws that govern the fisheries in question, and the findings are made part of each FMP. Each Fishery Management Council membership is comprised of state and federal officials responsible for resource management in their area. These two circumstances identify other collections that may be gathering the same or similar information. In addition, each FMP undergoes extensive public comment periods where potential applicants review the proposed permit application requirements. Therefore, NMFS is confident it is aware of similar collections if they exist. The FFWCC is collecting (or has already collected) similar information via its stone crab license permitting system. That information will utilized to determine eligibility for the Federal permitting program. However, this would not cause duplication in terms of permit issuance or data collection since the Federal permits are valid only in Federal waters and will not be issued to persons who already hold the state license/certificate.

The other information proposed to be collected is not being collected elsewhere; therefore, this data collection would not cause duplication.
5. If the collection of information involves small businesses or other small entities, describe the methods used to minimize burden.

Because all applicants are considered small businesses, separate requirements based on size of business have not been developed. Only the minimum data to meet the current and future needs of NMFS' fisheries management and permitting programs are requested from all applicants.
6. Describe the consequences to the Federal program or policy activities if the collection is not conducted or is conducted less frequently.

If we did not identify and control the participants in all of the commercial permit fisheries in the region, through the permit system, it would critically impact the management of our fishery resources. Collection of the vessel-specific information whenever the application is completed is necessary for NMFS to properly the applicable permit transfer provisions in effect for those fisheries. Since that information may change over time, periodic collection is needed.

## 7. Explain any special circumstances that require the collection to be conducted in a manner inconsistent with OMB guidelines.

The collection is consistent with OMB guidelines.

The proposed rule to implement Amendment 7 includes a notice of and request for comments on this data collection.

Because these data collection programs are part of fishery management plans, all aspects of the programs have been reviewed by both statistical and constituent advisory committees.
Furthermore, comments and suggestions from fishermen, that are required to report, are routinely submitted and these are reviewed and considered. Experience with the various programs, some of which have been operating for many years, provides a continual feedback mechanism to NMFS on issues and concerns to the applicants. There are no major problems that have not been resolved.

## 9. Explain any decisions to provide payments or gifts to respondents, other than remuneration of contractors or grantees.

There are no payments or other remunerations to respondents.
10. Describe any assurance of confidentiality provided to respondents and the basis for assurance in statute, regulation, or agency policy.

All data that are submitted are treated as confidential in accordance with NOAA Administrative Order 216-100.

## 11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private.

No questions of a sensitive nature are asked.

## 12. Provide an estimate in hours of the burden of the collection of information.

Under the program change, the NMFS expects to receive stone crab fishing permit requests/applications from 30 vessels, each taking 0.33 hours to complete. Of those, 20 vessels are expected to qualify for and be issued Federal stone crab permits/certificates/trap tags. Ten of those vessels are expected to already have other Federal fishing permits (and therefore are already using the Application for renewals). Those ten vessels would submit an additional request without using another application to add the stone crab permit as soon as possible. Therefore, those ten vessels would each have a response in the first year. The new stone crab permit category, therefore, will result in 30 annual responses (from 30 respondents) and ten annual burden hours in the first year, assuming an estimated time of 0.33 hours per response. The stone crab vessels that obtain permits will then be placed in the automatic renewal cycle wherein applications are only required every other year.

The proposed rule provides for the collection of vessel-specific information regarding landings of stone crab in the management area but outside Florida's trip ticket reporting system. Such landings would instead be documented by fishermens' collection of dealer landings records, estimated to take two hours for each response. It is estimated that ten of the 30 applications would involve fishermens' collection of such records for submittal to NMFS. The additional burden time for this would be 20 hours total. NMFS would obtain Florida's trip ticket data via electronic transmittal directly from Florida without additional applicant burden time, and will be used by NMFS to calculate eligibility and the maximum allowable number of traps.

The proposed rule also provides for submissions of appeals of NMFS' initial denial of a commercial vessel permit, as required to properly administer the Federal permit program. NMFS expects ten applications will be found initially ineligible for the Federal stone crab permit (those vessels still have to pay the processing fee). NMFS expects to receive one-time appeals regarding five of the ten applications expected to be initially ineligible. Additional record search and review time would be needed for each appellant to prepare the ineligibility appeal. Each appeal submission is expected to take five hours; therefore, the burden hours for the five appeals in the first year total 25 hours. Those appeals are not expected to be successful; therefore, no additional burden time is expected following completion of the appeals process.

In the first year, a total of 35 responses (i.e., 30 new applications plus five appeal responses) from 30 respondents is expected. These 35 responses are expected to take 55 hours in the first year (ten hours for completion of the Application, plus 20 hours for record collection by fishermen, plus 25 hours for the appeals).

## 13. Provide an estimate of the total annual cost burden to the respondents or recordkeepers resulting from the collection.

A fee is charged for each permit application submitted (regardless of whether or not the application meets the criteria and is approved). The amount of each fee is calculated in accordance with the procedures of the NOAA Finance Handbook for determining the administrative cost of each special product or service. Under the schedule, an applicant filling out the application is charged $\$ 50$ for the first permit category, and $\$ 20$ for the second permit category applied for at that time. The fees total $\$ 700$ per year, based on the following calculations. The ten stone crab vessels that are currently unpermitted will need to pay $\$ 50$ for the processing fee (sub-total of $\$ 500$ ). The 20 stone crab permit applicants that already hold other fishing permits will need to pay $\$ 20$ each for the processing fee that is charged every other year, to add the stone crab vessel permit category (sub-total of $\$ 400$ per year).

Each of the 20 stone crab vessels that will qualify for the Federal permit are expected to request 250 trap tags that will cost $\$ 1.30$ each, for a tag cost sub-total of $\$ 6,500$. The resulting sub-total of fees and tag costs, therefore, is $\$ 7,400$.

In addition, the public pays mailing costs for the various responses. Those mailing costs are estimated at $\$ .34$ average for each of the 30 applications, or $\$ 10.20$ total per year. Each of the five appeals are expected to require copying (duplicating) of ten pages each (at $\$ 0.10$ per page) in the first year. These first-year duplication costs are estimated at a total of $\$ 5.00$ per year. The sub-total of mailing and duplication costs in the first year is $\$ 15.20$.

The grand total, therefore, is $\$ 7,415.20$. No other cost burdens are expected from the other components of this collection.

The administrative costs for the program are paid by the fishermen. As a result, there is no cost to the Federal government.

GULF COASTAL MIGRATORY PELAGIC CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish or possess a coastal migratory pelagic fish in or from Federal waters, a permit must be issued to the vessel and be on board.

GULF REEF FISH CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish for or possess a reef fish in or from Federal waters of the Gulf of Mexico, a permit must be issued to the vessel and be on board.

SOUTH ATLANTIC COASTAL MIGRATORY PELAGIC CHARTER or SOUTH ATLANTIC SNAPPER-GROUPER CHARTER - For a person aboard a vessel that is operating as a charter vessel or headboat to fish for or possess coastal migratory pelagic charter or snapper-grouper in or from Federal waters off the south Atlantic states, a permit must be issued to the vessel and be on board.

KING MACKEREL - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits and to fish under a commercial allocation for king mackerel, a commercial vessel permit must be issued to the vessel and be on board. Permits for king mackerel are under a moratorium. Permits must be renewed within one year of the expiration date to avoid loss of permit. No new vessel may be permitted except by transfer of an existing permit. To transfer a permit, the valid permit must be returned with the application.

GILLNET ENDORSEMENT FOR KING MACKEREL - For a person aboard a vessel in Federal waters to use a run-around gillnet for king mackerel in the southern Florida west coast subzone, a commercial gillnet endorsement vessel permit for king mackerel must be issued to the vessel and be on board. Permits for gillnet endorsement for king mackerel are under a moratorium. No new vessel may be permitted except by transfer of an existing permit. To transfer a permit, the valid permit must be returned with the application.

REEF FISH (Gulf of Mexico) - As a prerequisite to sell reef fish in or from Federal waters and to be eligible for exemption from the bag limits, a vessel permit must be issued to the vessel and be on board. Permits for the reef fish fishery are under a moratorium. Permits must be renewed within one year of the expiration date to avoid loss of permit. No new vessels may be permitted except by transfer of an existing permit. To transfer a permit, the valid permit must be returned with the application.

ROCK SHRIMP (South Atlantic) - For a person aboard a fishing vessel to fish for rock shrimp in Federal waters or possess rock shrimp in or from Federal waters, a vessel permit for rock shrimp must be issued to the vessel and be on board.

SNAPPER-GROUPER EXCLUDING WRECKFISH (South Atlantic) - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits, to engage in a directed fishery for tilefish or to use a sea bass pot, a vessel permit must be issued to the vessel and be on board. Permits for the South Atlantic snapper-grouper fishery are under a moratorium. No new vessels may be permitted except by transfer of existing permits. A person desiring to acquire a limited access transferable permit for South Atlantic Snapper-grouper must obtain and exchange two such permits for one new permit. The valid permits must be returned with the application. Permits must be renewed within 60 days of the expiration date to avoid loss of permit.
SHARK - As a prerequisite to sell a shark in or from Federal waters and to be eligible for exemption from the bag limits, a vessel permit must be issued to the vessel and be on board. Permits for the shark fishery are under a moratorium. Permits must be renewed within one year of the expiration date to avoid loss of permit. No new vessels may be permitted except by transfer of an existing limited entry permit. To transfer a permit, the valid permit must be returned with the application.

SHRIMP (Gulf of Mexico) - For a person aboard a fishing vessel to fish for or possess Gulf of Mexico shrimp in or from Federal waters, a vessel permit for Gulf of Mexico Shrimp must be issued to the vessel and be on board.

SPANISH MACKEREL - For a person aboard a vessel in Federal waters to be eligible for exemption from the bag limits and to fish under a commercial allocation for Spanish mackerel, a commercial vessel permit must be issued to the vessel and be on board.

SPINY LOBSTER - For a vessel fishing in Federal waters off states other than Florida to be exempt from the daily catch and possession limit, a commercial spiny lobster permit must be issued to the vessel and be on board. Florida's requirements apply to a vessel fishing in Federal waters off Florida. To possess a separated spiny lobster tail in or from Federal waters, a tail-separation permit must be issued to the vessel and be on board. For fishing activities in Federal waters off states other than Florida, the tailing permit must be accompanied by a commercial spiny lobster permit.

SWORDFISH - To fish for or possess swordfish in or from the North Atlantic Ocean, or take swordfish as bycatch, whether or not retained, a vessel permit must be issued to the vessel and be on board. Permits for the swordfish fishery are under a moratorium. Permits must be renewed within one year of the expiration date to avoid loss of permit. No new vessels may be permitted except by transfer of an existing limited entry permit. To transfer a permit, the valid permit must be returned with the application.

EXPRESS air bill, complete with your delivery address, telephone number, and your FEDEX account number or credit card number.

## In accordance with Federal regulations, any change in your permit information must be reported to the NMFS Regional Administrator within 30 days of the change.

If individual is placing their Class 1 Red Snapper license on a vessel owned by a another entity, they must submit an application, check/money order, vessel Coast Guard Documentation or State Registration of vessel owner, and original permit.

Transfer of 225-pound Trip Limit Permit New Owner: The permit is not transferable to a new owner.

For a corporation/partnership owned vessel, percentage of earned income requirement must be met by an officer or shareholder of the corporation, a general partner or the vessel operator. When an officer/shareholder/partner documents his/her earned income from fishing, the corresponding corporate or partnership documented income, including shareholder's share of income and copy of Articles of Incorporation, must be submitted. The documentation must specify the calender year for which it applies. Instead of these individual items of information, the officer/shareholder/partner may submit copies of his/her individual income tax return and the corresponding corporate or partnership income tax return, including Schedule K-1, but should obliterate information that is personally private such as social security numbers.

If using gross sales alternative, the applicant must submit copies of receipts indicating sales of fish harvested from the owner's, operator's, corporation's or partnership's vessel for a specified year. Instead of such receipts, the applicant may submit copies of those portions of the individual/corporation income tax return that show this information, i.e., Pages 1 \& 2 of Schedule C, C-EZ, Form 1120, 1120A, 1120S or 1065, but should obliterate information that is personally private such as social security numbers.

Previously submitted documentation that meets the time frame for qualification need not be resubmitted. Renewal of a permit that was issued based on the earned income of an operator must be accompanied by new documentation of earned income when a new or additional operator meets the requirements. Copies of income tax forms and schedules and all information submitted for documentation or earned income from fishing or gross sales of fish are treated as confidential.

## LIMITED ENTRY FOR CERTAIN SOUTHEASTERN FISHERIES

The National Marine Fisheries Service (NMFS), Southeast Regional Office, wishes to remind interested parties that limited entry programs are in place or under consideration for the following commercial and recreational fisheries operating in Federal waters of the southeastern U.S. Anyone intending to purchase vessels or gear for the purpose of entering one of these fisheries is advised to pay close attention to the following information. Gulf Reef Fish - The commercial Gulf reef fish fishery is closed to new entrants through December 31, 2005, except by transfer of an existing permit to another vessel.

No new commercial red snapper licenses are being issued. Class 1 red snapper licenses allow a 2,000 pound trip limit; Class 2 licenses allow a 200 pound trip limit. An existing license may be transferred to another vessel.

No new fish trap endorsements are being issued. Use of fish traps will be prohibited throughout the Gulf of Mexico exclusive economic zone after February 7, 2007. Existing fish trap endorsements are transferable to other reef fish permitted vessels through February 7, 1999. After that date, transfer of fish trap endorsements is allowed only under certain circumstances.

A control date of November 18, 1998, has been established for the recreational-for-hire (charter vessel and headboat) fishery for reef fish and coastal migratory pelagic species in Federal waters of the Gulf of Mexico. Anyone entering this fishery after its control date may not be assured of future participation if a limited entry program is adopted.

Gulf Stone Crab - There is a moratorium on Federal registration of commercial stone crab vessels through June 30, 2002. NMFS has implemented a limited entry program. A control date of July 24, 1995, has been established for this fishery. Anyone entering the fishery after its control date may not be assured of future participation if a limited entry program is adopted in Federal waters.

South Atlantic Golden Crab - The commercial fishery is closed to new entrants except by transfer of an existing permit or permits.

South Atlantic Rock Shrimp - A control date of April 4, 1994, has been established for the commercial fishery. Anyone entering the fishery after its control date may not be assured of future participation if a limited entry program is adopted.

South Atlantic Snapper-Grouper - The commercial fishery is closed to new entrants unless they can obtain two "transferable" permits to exchange for one new permit.

A control date of April 23, 1997, has been established for the commercial black sea bass pot fishery. Anyone entering this fishery after its control date may not be assured of future participation if a limited entry program is implemented.

South Atlantic Wreckfish - The commercial fishery is closed to new entrants except through purchase of individual transferable quota shares.

Gulf and South Atlantic Coastal Migratory Pelagics - The commercial fishery for king mackerel is closed to new entrants through October 15, 2005, except by transfer of an existing permit to another vessel.

A control date of July 2, 1993, has been established for the commercial Spanish mackerel fishery. Anyone entering this fishery after its control date may not be assured of future participation if a limited entry system is adopted.

The South Atlantic Fishery Management Council has requested that NMFS implement control dates for the commercial dolphin-wahoo fishery in Federal waters of the South Atlantic region and the Atlantic group king mackerel gillnet fishery north of Cape Lookout, NC.

A control date of November 18, 1998, has been established for the recreational-for-hire (charter vessel and headboat) fishery for reef fish and coastal migratory pelagic species in Federal waters of the Gulf of Mexico. Anyone entering this fishery after its control date may not be assured of future participation if a limited entry program is adopted.

Gulf and South Atlantic Spiny Lobster - Florida's commercial gear identification and trap certificate/reduction programs are in effect in Federal waters off Florida. Contact the Florida Marine Fisheries Commission at 850/4870554.

Highly Migratory Species - For information on limited entry programs for shark, billfish, swordfish, or tuna fisheries, please contact the Highly Migratory Species Division at 727/570-5447 or 301/713-2347.

(2) designate zones where, and periods when, fishing shall be limited, or shall not be permitted, or shall be permitted only by specified types of fishing vessels or with specified types and quantities of fishing gear;
(3) establish specified limitations which are necessary and appropriate for the conservation and management of the fishery on the--
(A) catch of fish (based on area, species, size, number, weight, sex, bycatch, total biomass, or other factors);
(B) sale of fish caught during commercial, recreational, or charter fishing, consistent with any applicable Federal and State safety and quality requirements; and
(C) transshipment or transportation of fish or fish products under permits issued pursuant to section 204;
(4) prohibit, limit, condition, or require the use of specified types and quantities of fishing gear, fishing vessels, or equipment for such vessels, including devices which may be required to facilitate enforcement of the provisions of this Act;
(5) incorporate (consistent with the national standards, the other provisions of this Act, and any other applicable law) the relevant fishery conservation and management measures of the coastal States nearest to the fishery;
(6) establish a limited access system for the fishery in order to achieve optimum yield if, in developing such system, the Council and the Secretary take into account--
(A) present participation in the fishery,
(B) historical fishing practices in, and dependence on, the fishery,
(C) the economics of the fishery,
(D) the capability of fishing vessels used in the fishery to engage in other fisheries,
(E) the cultural and social framework relevant to the fishery and any affected
fishing communities, and
(F) any other relevant considerations;
(7) require fish processors who first receive fish that are subject to the plan to submit data (other than economic data) which are necessary for the conservation and management of the fishery;
(8) require that one or more observers be carried on board a vessel of the United States engaged in fishing for species that are subject to the plan, for the purpose of collecting data necessary for the conservation and management of the fishery; except that such a vessel shall not be required to carry an observer on board if the facilities of the vessel for the quartering of an observer, or for carrying out observer functions, are so inadequate or unsafe that the health or safety of the observer or the safe operation of the vessel would be jeopardized;
(9) assess and specify the effect which the conservation and management measures of the plan will have on the stocks of naturally spawning anadromous fish in the region;
(10) include, consistent with the other provisions of this Act, conservation and management measures that provide harvest incentives for participants within each gear group to employ fishing practices that result in lower levels of bycatch or in lower levels of the mortality of bycatch;
(11) reserve a portion of the allowable biological catch of the fishery for use in scientific research; and
(12) prescribe such other measures, requirements, or conditions and restrictions as are determined to be necessary and appropriate for the conservation and management of the fishery. 97-453, 104-297
