Thionyl chloride is used to manufacture agricultural pesticides and pharmaceutical intermediates. The chemical is also used in the chemical industry as a mild chlorinating agent. A specialized use of thionyl chloride is to make protease inhibitors for HIV treatment. It is imported from Switzerland and Germany.

- 3 SECTION 1. THIONYL CHLORIDE.
- 4 (a) IN GENERAL.—Heading 9902.28.01 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 Thionyl chloride) is amended by striking the date in the
- 7 effective period column and inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies with respect to goods entered, or
- 10 withdrawn from warehouse for consumption, on or after
- 11 the 15th day after the date of the enactment of this Act.
