The subject chemical, which is imported from China, is an intermediate that is used in the production of an active ingredient that is used to formulate herbicides for post emergence grass weed control in wheat and barley. The herbicide provides control of a broad spectrum of grass weeds and provides a significant degree of crop safety on barley.

The word "stirking" in line 6 of the bill is misspelled and should be replaced by the word "striking."

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
