6 Propanoic acid, 2-[4-(cyano-2-fluorophenoxy)phenoxy]7 butyl ester (2R)) is amended—

8 (1) by striking "1.5%" and inserting "2.0%";9 and

10 (2) by striking "12/31/2009" and inserting
11 "12/31/2011".

(b) EFFECTIVE DATE.—The amendments made by
 subsection (a) shall take effect on January 1, 2010.
