### A BILL

To extend and modify the temporary suspension of duty on Myclobutanil.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. MYCLOBUTANIL.

(a) IN GENERAL.—Heading 9902.02.91 of the Harmonized Tariff Schedule of the United States is amended ed—

(1) by striking "3%" and inserting "2.3%";

and

(2) by striking "12/31/2009" and inserting

"12/31/2011".

- 3 withdrawn from warehouse for consumption, on or after

4 January 1, 2010.
