Technical comments:⁴

The Commission staff suggests that the existing heading, 9902.23.49, be used to extend the duty suspension for the subject product.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
