Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Camel hair, not processed in any manner beyond the degreased or carbonized condition (provided for in subheading 5102.19.20).

Product information, including uses/applications and source(s) of imports:

Retroactive effect: None.

Camel hair is a specialty animal hair that is often used in its original tan color. The camel hair covered by this bill is degreased and/or carbonized. Degreasing removes the grease and dirt from the animal hair, while carbonization removes vegetable matter from the hair. Such camel hair is often used in the production of yarns, which are woven into fabrics. Such camel hair is imported under HTS subheading 5102.19.20, which covers hair of the camel, not processed in any manner beyond the degreased or carbonized condition. U.S. imports under HTS subheading 5102.19.20 totaled \$23,517 in 2007. Imports from China accounted for 99 percent of the total.

- 4 BEYOND THE DEGREASED OR CARBONIZED
- 5 CONDITION.
- 6 (a) In General.—Heading 9902.12.24 of the Har-
- 7 monized Tariff Schedule of the United States is amended
- 8 by striking "12/31/2009" and inserting "12/31/2011".
- 9 (b) Effective Date.—The amendment made by
- 10 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
