Caprolactone-2-ethyl-2-(hydroxymethyl)-1,3-propanediol polymer (CAS No. 37625-56-2) (provided for in subheading 3907.99.01).

Product information, including uses/applications and source(s) of imports:

The subject product is a high performance caprolactone triol that is derived by polymerizing epsiloncaprolactone monomer with trimethylol propane as an initiator. This polymer is a colorless liquid known for its superior chemical, abrasion, hydrolytic, and UV resistance compared to other polyesters. The product is primarily used to produce solvent-based, high-solids coatings. It is imported from Japan and the United Kingdom.
