The subject product is a synthetic organic chemical that is used as an intermediate in the manufacture of pesticides, sunscreens, and biodiesel fuel. It is imported from Germany, China, and Singapore.⁴

- 6 by striking "12/31/2009" and inserting "12/31/2011".
- 7 (b) Effective Date.—The amendment made by
- 8 subsection (a) applies with respect to goods entered, or
- 9 withdrawn from warehouse for consumption, on or after
- 10 the 15th day after the date of the enactment of this Act.
