The subject product is an intermediate that is used in the production of a herbicide that provides postemergence control of grass and broadleaf weeds in corn, including weeds resistant to glyphosate and other chemical classes. The herbicide provides crop safety and maximum rotation flexibility to soybeans and many other common rotation crops. The subject product is imported from China.
