Technical comments:⁴

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

The Commission staff notes that HTS heading 9902.02.01 provided a temporary duty suspension for the subject product that expired on December 31, 2006. The effective date of heading 9902.02.01 should be amended to renew the temporary duty suspension. In addition, the article description of heading 9902.02.01 should be amended to use the article description on page 1 of this report because it contains the preferred chemical name.
