<sup>&</sup>lt;sup>4</sup> According to a staff conversation with James Hedrick, rare earth specialist for the U.S. Geological Survey on March 25, 2008, U.S. Customs informed him that a mixture of cerium compounds and another rare earth compound or yttrium or scandium would be classified under HTS subheading 2846.10.00 (cerium compounds) as long as the cerium content is greater than 50 percent. If the cerium content is less than 50 percent, the mixture would be classified under HTS subheading 2846.90.80.

- 6 monized Tariff Schedule of the United States is amended
- 7 by striking "12/31/2009" and inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
