Nature of bill: Temporary duty suspension through December 31, 2011.

Aqueous mixtures of polyvinyl alcohol (CAS No. 98002-48-3) and polyvinylpyrrolidone (CAS No. 9003-39-8) (provided for in subheading 3905.99.80).

Product information, including uses/applications and source(s) of imports:

The subject product is a dilute aqueous mixture of various concentrations of polyvinyl alcohol and polyvinylpyrrolidone. It is used as an additive in cement slurries for the capping of gas wells. The product is imported from France.

The Commission staff recommends that the article description on page 1 of this report be used in the proposed new heading in order to provide the correct spelling of the chemical name and to modify the article description to reflect an aqueous mixture.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

3 **SECTION 1. MIXTURES OF POLYVINYL ALCOHOL AND POLY-**
4 **VINYL PYRROLIDONE.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following
8 new heading:

“ 9902.____	Mixtures of polyvinyl alcohol (CAS No. 98002-48-3) and polyvinyl pyrrolidone (CAS No. 9003-39-8) (provided for in subheading 3905.99.80)	Free	No change	No change	On or before 12/31/2011	”.
