#### Product information, including uses/applications and source(s) of imports:

The subject synthetic organic chemical, more commonly known as TETD, is used to provide heat-aging and compression-set resistance for rubber products that are produced by sulfur-less and efficient vulcanization systems. The product is imported from Germany and China.

- 7 date in the effective period column and inserting "12/31/
- 8 2011".
- 9 (b) Effective Date.—The amendment made by
- 10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
