The subject product is a synthetic organic chemical that is used to treat industrial polyester fabrics to increase adhesion of the polyester to natural rubber when making tires and industrial rubber products, such as conveyor belts and hoses. The product is imported from Switzerland.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. GRILBOND IL 6–50%F.**

4        (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following  
7 new heading:
