N,N,N',N'-Tetrakis(2-hydroxypropyl)-hexanediamide (CAS No. 57843-53-5) (provided for in subheading 2924.19.80).

#### Product information, including uses/applications and source(s) of imports:

The subject product is an active ingredient that is reacted with polyester resins to make weather-resistant powder coatings. Powder coatings are solids that are applied as powders by electrostatic means in a manner that avoids the use of volatile organic solvents. Volatile organic solvents are an environmental contaminant regulated in most States. Direct electrostatic application of powders also reduces material waste and air pollution caused by "blow-by" of liquid sprays. High-temperature curing of the applied coating provides good weather-resistance. The product is imported from Switzerland.
