Product information, including uses/applications and source(s) of imports:

A hand-held electric can opener has a pliers-like handle used to clamp a cutting wheel against a metal can's lid and a handgrip that rotates the can to cut the lid around the rim. The device is powered by a small electric motor encased in a housing. The principal import source of these can openers is China, which shipped approximately \$28.4 million of the \$28.5 million in total dutiable imports of electric can openers under HTS statistical reporting number 8509.80.5010 in 2007.

- 4 (a) In General.—Heading 9902.23.38 of the Har-
- 5 monized Tariff Schedule of the United States is amended
- 6 by striking "12/31/2009" and inserting "12/31/2011".
- 7 (b) Effective Date.—The amendment made by
- 8 subsection (a) applies with respect to goods entered, or
- 9 withdrawn from warehouse for consumption, on or after
- 10 the 15th day after the date of the enactment of this Act.
