Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Benzeneacetic acid, (E)-2-[[6-(2-cyanophenoxy)-4-pyrimidinyl]oxy]- $\alpha$ -(methoxymethylene)-, methyl ester (Azoxytrobin, Pyroxystrobin) (CAS No. 131860–33–8) (provided for in subheading 2933.59.15).

#### Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic fungicide, which has a chemical structure that is based on that of naturally occurring fungicides called strobilurins. The product is imported from the United Kingdom.

To extend the suspension of duty on pyroxystrobin.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PYROXYSTROBIN.
- 4 (a) IN GENERAL.—Heading 9902.02.06 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 pyroxystrobin) is amended by striking "12/31/2009" and
- 7 by inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies to goods entered, or withdrawn from
- 10 warehouse for consumption, on or after the 15th day after
- 11 the date of the enactment of this Act.
