Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of 1H-1,2,4-triazole, 1-((2-chlorophenoxy)phenyl)-4-methyl-1,3-dioxolan-2-yl)methyl)-(Difenoconazole) (CAS No. 119446-68-3), (R,S)-2-((2,6-dimethylphenyl)methoxyacetylamino)propionic acid, methyl ester (Mefenoxam) (CAS Nos. 70630-17-0, and 69516-34-3) and application adjuvants (provided for in subheading 3808.92.15).

#### Product information, including uses/applications and source(s) of imports:

The subject product is a mixture of synthetic organic fungicides that are used as seed treatment to prevent the development of fungal disease on crops when the plant is most vulnerable. It is imported from Canada.<sup>4</sup>

- 8 by striking "12/31/2009" and by inserting "12/31/2011".
- 9 (b) Effective Date.—The amendment made by
- 10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
