The subject product is a synthetic organic chemical that is used by the proponent as an intermediate in the production of food dyes. The subject product is imported from India and China.

5 **[(ETHYLPHENYLAMINO)METHYL]-).**

6 (a) IN GENERAL.—Heading 9902.01.68 of the Har-  
7 monized Tariff Schedule of the United States is amended  
8 by striking “12/31/2009” and inserting “12/31/2011”.

9 (b) EFFECTIVE DATE.—The amendment made by  
10 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
