The subject product, a synthetic organic chemical, is used to manufacture herbicides. It is also one of the primary precursors in the production of sorbic acid. This toxic water-white liquid has a suffocating odor. It is imported from Germany and Japan, among other sources.

- 6 Crotonaldehyde (2-butenaldehyde)) is amended by striking
- 7 "12/31/2009" and inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies with respect to goods entered, or
- 10 withdrawn from warehouse for consumption, on or after

- 1 the date that is 15 days after the date of enactment of
- 2 this Act.
